Dear Mr. Sherman:

I am writing to advise the Pennsylvania Gaming Control Board that on March 13, 2012, Greenwood Racing, Inc. ("GRI") completed a stock redemption transaction that involved less than 5% of the outstanding Class A common shares of GRI. GRI redeemed 7,981.00 shares of Class A common stock owned by Mr. Green. As a result of this transaction, Mr. Green's holding has decreased by 1.9994% of the Class A shares outstanding immediately prior to the redemption. Mr. Green now holds 11,376 Class A shares (3.0000% of the Class A shares outstanding).

Concurrent with this redemption, in a separate transaction, International Turf Investment Company, Inc. ("ITIC") transferred 7,500 shares of Class A common stock to its 99% subsidiary, ITIC/ITAC LLC, to facilitate tax reporting. As a result of this transaction, ITIC's holding has decreased by 0.3162% of the Class A shares after giving effect to the redemption and transfer, and ITIC/ITAC LLC's holding has increased by 2.0648% of the Class A shares after giving effect to the redemption and transfer. ITIC now holds 298,184.14 Class A shares (78.6340% of the Class A shares outstanding) and ITIC/ITAC LLC now holds 23,500 Class A shares (6.1972% of the Class A shares outstanding).
