UNLESS OTHERWISE PROVIDED FOR IN THE GAMING ACT AND REGULATIONS, EACH PRINCIPAL; PERSON WITH CONTROLLING INTEREST; INSTITUTIONAL INVESTOR AND FINANCIAL BACKER WHO IS AN ENTITY MUST COMPLETE THE PRINCIPAL ENTITY. FORM OR THE PRINCIPAL WAIVER FORM - ENTITY.

PRINCIPAL - 4 PA.C.S. §1.103 DEFINES PRINCIPAL AS "AN OFFICER; DIRECTOR; PERSON WHO DIRECTLY HOLDS A BENEFICIAL INTEREST IN OR OWNERSHIP OF THE SECURITIES OF AN APPLICANT OR LICENSEE; PERSON WHO HAS A CONTROLLING INTEREST IN AN APPLICANT OR LICENSEE, OR HAS THE ABILITY TO ELECT A MAJORITY OF THE BOARD OF DIRECTORS OF A LICENSEE OR TO OTHERWISE CONTROL A LICENSEE; LENDER OR OTHER LICENSEE FINANCIAL INSTITUTION OF AN APPLICANT OR LICENSEE, OTHER THAN A BANK OR LENDING INSTITUTION WHICH MAKES A LOAN OR HOLDS A MORTGAGE OR OTHER LICENSEE, INTERVIDED IN THE ORDINARY COURSE OF BUSINESS; UNDERWRITER OF AN APPLICANT OR LICENSEE; OR OTHER PERSON OR EMPLOYEE OF AN APPLICANT, SLOT MACHINE LICENSEE, MANUFACTURER LICENSEE OR SUPPLIER LICENSEE DEEMED TO BE A PRINCIPAL BY THE PENNSYLVANIA GAMING CONTROL BOARD."

DIRECTOR -- BOARD REQULATIONS DEFINE DIRECTOR AS "A DIRECTOR OF A CORPORATION OR ANY PERSON PERFORMING SIMILAR FUNCTIONS WITH RESPECT TO AN ENTITY, WHETHER INCORPORATED OR UNINCORPORATED."

OFFICER — BOARD REGULATIONS DEFINE OFFICER, AS "A PRESIDENT, CHIEF EXECUTIVE OFFICER, CHIEF OPERATING OFFICER, SECRETARY, TREASURER, PRINCIPAL LEGAL OFFICER, PRINCIPAL FINANCIAL OFFICER, COMPTROLLER, PRINCIPAL ACCOUNTING OFFICER, CHIEF ENGINEER OR TECHNICAL OFFICER OF A MANUFACTURER, OR PRINCIPAL SLOT OPERATIONS OFFICER OF A SLOT MACHINE LICENSEE AND ANY PERSON ROUTINELY PERFORMING CORRESPONDING FUNCTIONS WITH RESPECT. TO AN ENTITY WHETHER INCORPORATED OR UNINCORPORATED."

KEY EMPLOYEE - 58 PA. CODE \$401A.3 DEFINES KEY EMPLOYEE AS "ANY INDIVIDUAL WHO IS: (I) EMPLOYED IN A DIRECTOR OF DEPARTMENT, HEAD CAPACITY AND WHO IS EMPOWERED TO MAKE DISCRETIONARY DECISIONS THAT REGULATE SLOT MACHINE OPERATIONS IN THIS COMMONWEALTH, INCLUDING THE GENERAL MANAGER AND ASSISTANT MANAGER OF THE LICENSED FACILITY, DIRECTOR OF SLOT OPERATIONS, DIRECTOR OF CAGE AND CREDIT OPERATIONS, DIRECTOR OF SURVEILLANCE, DIRECTOR OF MARKETING, DIRECTOR OF MANAGEMENT INFORMATION SYSTEMS, DIRECTOR OF SECURITY, COMPTROLLER AND ANY EMPLOYEE WHO SUPERVISES THE OPERATIONS OF THESE DEPARTMENTS OR TO WHOM THESE DEPARTMENT DIRECTORS OR DEPARTMENT HEADS REPORT; (II) EMPLOYED, BY, A: SLOT, MACHINE, LICENSEE OR APPLICANT; MANUFACTURER LICENSEE OR APPLICANT; SUPPLIER LICENSEE OR APPLICANT, CERTIFIED VENDOR OR APPLICANT, OR LICENSED JUNKET ENTERPRISE WHOSE DUTIES AFFECT OR REQUIRE CONTACT WITH SLOT MACHINES; SLOT MONITORING SYSTEMS, CASINO MANAGEMENT SYSTEMS, PLAYER TRACKING SYSTEMS AND WIDE- AREA PROGRESSIVE SYSTEMS FOR USE OR PLAY IN THE COMMONWEALTH; WHETHER OR NOT THE INDIVIDUAL IS ASSIGNED TO GAMING OPERATIONS IN THE COMMONWEALTH AND (III) OTHER POSITIONS WHICH THE BOARD WILL DETERMINE BASED ON DETAILED ANALYSES. OF JOB DESCRIPTIONS AS PROVIDED IN THE INTERNAL CONTROLS OF THE APPLICANT OR LICENSEE AS APPROVED BY THE BOARD UNDER \$1322(C) OF THE ACT (RELATING TO SLOT MACHINE ACCOUNTING CONTROLS AND AUDITS). ALL OTHER GAMING EMPLOYEES UNLESS OTHERWISE DESIGNATED BY THE BOARD, WILL BE CLASSIFIED AS NON-KEY EMPLOYEES.

CONTROLLING INTEREST - 4-PA.C.S. §1103 DEFINES CONTROLLING INTEREST AS "FOR A PUBLICLY TRADED DOMESTIC OR FOREIGN CORPORATION, A CONTROLLING INTEREST IS AN INTEREST IN A LEGAL ENTITY, APPLICANT OR LICENSEE IF A PERSON'S SOLE VOTING RIGHTS UNDER STATE LAW OR CORPORATE OR CORPORATE ARTICLES

OR BYLAWS ENTITLE: THE PERSON TO ELECT OR APPOINT ONE OR MORE OF THE MEMBERS OF THE: BOARD OF DIRECTORS OR OTHER GOVERNING BOARD OR THE OWNERSHIP OR BENEFICIAL HOLDING OF,5% OR MORE OF THE SECURITIES OF THE PUBLICLY TRADED CORPORATION, PARTNERSHIP, LIMITED LIABILITY COMPANY OR OTHER FORM OF PUBLICLY TRADED LEGAL ENTITY, UNLESS THIS PRESUMPTION OF CONTROL OR ABILITY TO ELECT IS REBUTTED BY CLEAR AND CONVINCING EVIDENCE. INDIRECT OWNERSHIP INTEREST. — BOARD REGULATIONS DEFINE INDIRECT OWNERSHIP INTEREST AS "AN OWNERSHIP INTEREST IN AN APPLICANT OR LICENSEE, OR A DIRECT OWNERSHIP INTEREST IN AN APPLICANT OR LICENSEE THROUGH ONE OR MORE INTERVENING ENTITIES."

PUBLICLY TRADED CORPORATION - 4 PA: CODE \$1,103 DEFINES PUBLICLY TRADED CORPORATION AS "A PERSON, OTHER THAN AN INDIVIDUAL, WHICH:

- (1) HAS A CLASS OR SERIES OF SECURITIES REGISTERED UNDER THE SECURITIES EXCHANGE ACT OF 1934 (48 STAT. 881, 15 U.S.C. 78A ET SEQ.);
- (2) IS A REGISTERED MANAGEMENT COMPANY UNDER THE INVESTMENT COMPANY ACT OF 1940 (54 STAT. 789, 15 U.S.C. 80A-1 et SEQ.); OR
- (3) IS SUBJECT TO THE REPORTING OBLIGATIONS IMPOSED BY SECTION 15(D) OF THE SECURITIES EXCHANGE ACT OF 1934 BY REASON OF HAVING FILED A REGISTRATION STATEMENT WHICH HAS BECOME EFFECTIVE UNDER THE SECURITIES ACT OF 1933 (48 STAT. 74, 15 U.S.C. 77A ET. SEC.)."

ENTITY - BOARD REGULATIONS DEFINE ENTITY/AS "A PERSON, OTHER THAN AN INDIVIDUAL."

INDIVIDUAL - BOARD REGULATIONS DEFINE AN INDIVIDUAL AS "A NATURAL PERSON."

UNDERWRITER - 4 PA. CODE § 1103 DEFINES UNDERWRITER AS DEFINED IN THE ACT OF DECEMBER 5, 1972 (P.L. 1280, No. 284), KNOWN AS THE PENNSYLVANIA SECURITIES ACT OF 1972."

INSTITUTIONAL INVESTOR - 58 PA. CODE § 401A.3 DEFINES AN INSTITUTIONAL INVESTOR AS "A RETIREMENT FUND ADMINISTERED BY A PUBLIC AGENCY FOR THE EXCLUSIVE BENEFIT OF FEDERAL, STATE OR LOCAL PUBLIC EMPLOYEES, INVESTMENT COMPANY REGISTERED UNDER THE INVESTMENT COMPANY ACT OF 1940 (15 U.S.C.A. §§ 80A-1 - 80A-64), COLLECTIVE INVESTMENT TRUST ORGANIZED BY BANKS UNDER PART NINE OF THE RULES OF THE COMPTROLLER OF THE CURRENCY, CLOSED END INVESTMENT TRUST, CHARTERED OR LICENSED LIFE INSURANCE COMPANY OR PROPERTY AND CASUALTY INSURANCE COMPANY, BANKING AND, OTHER CHARTERED OR LICENSED LENDING INSTITUTION, INVESTMENT, ADVISOR REGISTERED UNDER THE INVESTMENT ADVISORS ACT OF 1940 (15 U.S.C.A. §§ 80B-1 - 80B-21), AND SUCH OTHER PERSONS AS THE BOARD MAY DETERMINE CONSISTENT WITH THIS PART."

PRIVATE INVESTMENT FUND — BOARD REQUIATIONS DEFINE PRIVATE INVESTMENT FUND AS "AN ENTITY THAT MEETS THE DEFINITION OF "INVESTMENT COMPANY" UNDER SECTION 3(A)(1) OF THE INVESTMENT COMPANY ACT OF 1940 (15 U.S.C. 80A-3(A)(1)), BUT IS OTHERWISE EXEMPT FROM THE DEFINITION OF "INVESTMENT COMPANY UNDER SECTION 3(C)(7) OF THE INVESTMENT COMPANY ACT OF 1940 (15 U.S.C. 80A-3 (C)(7)).

REGISTERED INVESTMENT COMPANY — BOARD REGULATIONS DEFINE A REGISTERED INVESTMENT COMPANY AS "AN INVESTMENT COMPANY THAT HAS REGISTERED WITH THE SEC PURSUANT TO THE INVESTMENT COMPANY ACT OF 1940."

REGISTERED INVESTMENT ADVISER - BOARD REGULATIONS DEFINE REGISTERED INVESTMENT ADVISER AS "AN INVESTMENT ADVISER THAT HAS REGISTERED WITH THE SEC PURSUANT TO THE INVESTMENT ADVISERS ACT OF 1940."

L'ENDING INSTITUTION - BOARD REGULATIONS DEFINE À L'ENDING INSTITUTION ÀS "A PERSON WHO HÀS BEEN ISSUED À LICENSE TO L'END MONEY BY A STATE OR FEDERAL AGENCY OR À PERSON WHO SATISFIES THE DEFINITION OF QUALIFIED INSTITUTIONAL BUYER PURSUANT TO 17 C.F.R. § 230:144A."

AFFILIATE, AFFILIATE OF OR PERSON AFFILIATED WITH - 4 PA.C.S. § 1103 DEFINES AFFILIATE, AFFILIATE OF OR PERSON THAT DIRECTLY OR INDIRECTLY, THROUGH ONE OR MORE INTERMEDIARIES, CONTROLS, IS CONTROLLED BY OR IS UNDER COMMON CONTROL WITH A SPECIFIED PERSON."

PRINCIPAL AFFILIATE - BOARD REGULATIONS DEFINE PRINCIPAL AFFILIATE AS "AN INTERMEDIARY OR HOLDING COMPANY OF AN APPLICANT OR LICENSEE."

PRINCIPAL ENTITY:—BOARDI REGULATIONS DEFINE PRINCIPAL ENTITY AS AN ENTITY THAT MEETS THE DEFINITION OF PRINCIPAL IN SECTION 1103. OF THE ACT (RELATING TO DEFINITIONS) OF ISO OTHERWISE REQUIRED TO BE LICENSED AS A PRINCIPAL AND IS NOT AN INTERMEDIARY OR HOLDING COMPANY OF AN APPLICANT OR LICENSEE."

SUBSIDIARY - 4 PA.C.S. S-1103 DEFINES SUBSIDIARY AS A PERSON OTHER THAN AN INDIVIDUAL. THE TERM INCLUDES:

- (1) A CORPORATION, ANY SIGNIFICANT PART OF WHOSE OUTSTANDING EQUITY SECURITIES ARE OWNED, SUBJECT TO A POWER OR RIGHT OF CONTROL, OR HELD, WITH POWER TO VOTE, BY/A HOLDING COMPANY OR AN INTERMEDIARY COMPANY;
- (2) A SIGNIFICANT INTEREST IN A PERSON, OTHER THAN AN INDIVIDUAL; WHICH IS OWNED, SUBJECT TO A. POWER OR RIGHT OF CONTROL, OR HELD WITH POWER TO VOTE, BY A HOLDING COMPANY OR AN INTERMEDIARY COMPANY, OR.
- (3) A PERSON DEÉMEDITO BE A SUBSIDIÁRY BY THE PENNSYLVANIA GAMING CONTROL BOARD."

INTERMEDIARY - 4 PA.C.S. § 1103 DEFINES INTERMEDIARY AS "A PERSON, OTHER THAN AN INDIVIDUAL, WHICH:

- (1) IS A HOLDING COMPANY WITH RESPECT TO A CORPORATION OR OTHER FORM OF BUSINESS ORGANIZATION, WHICH HOLDS OR APPLIES FOR A LICENSE UNDER THIS PART, AND
- (2) IS A SUBSIDIARY WITH RESPECT TO ANY HOLDING COMPANY."

HOLDING COMPANY - BOARD REGULATIONS DEFINE HOLDING COMPANY AS "A PERSON, OTHER THAN AN INDIVIDUAL, WHICH, DIRECTLY OR INDIRECTLY, OWNS, HAS THE POWER OR RIGHT TO CONTROL OR HAS THE POWER OR RIGHT TO VOTE 20% OR MORE OF THE OUTSTANDING VOTING SECURITIES OF A CORPORATION OR OTHER ENTITY: A HOLDING COMPANY INDIRECTLY HAS HOLDS OR FOWER, RIGHT OR SECURITY IF IT DOES SO THROUGH AN INTERESTIN A SUBSIDIARY OR SUCCESSIVE SUBSIDIARIES."

VOTING SECURITY - BOARD REQUESTIONS DEFINE VOTING SECURITY AS "A SECURITY OF OTHER INTEREST WHICH ENTITLES THE OWNER TO VOTE FOR THE ELECTION OF:

- (I) A DIRECTOR OF A CORPORATION.
- (II) A PERSON PERFORMING FUNCTIONS SIMILAR TO A DIRECTOR WITH RESPECT TO AN ORGANIZATION WHETHER INCORPORATED OR UNINCORPORATED.

FINANCIAL BACKER - 4 PA.C.S. § 1103 DEFINES FINANCIAL BACKER AS "AN INVESTOR, MORTGAGEE, BONDHOLDER, NOTE HOLDER OR OTHER SOURCES OF EQUITY OR CAPITAL PROVIDED TO AN APPLICANT OR LICENSED ENTITY."

PRELIMINARY

- 1. Subject as hereinafter provided, the regulations contained in Table A in the Schedule to the Companies (Memorandum and Articles of Association) Regulations 1988 (hereinafter referred to as "Table A") shall apply to the Company.
- 2. Clauses 37, 89 and 101 of Table A shall not apply to the Company but the Articles hereinafter contained, and the remaining Clauses of Table A, subject to the modifications hereinafter expressed, shall constitute the regulations of the Company.

PRIVATE COMPANY

3. The Company is a "Private Company" within the meaning of the Companies Act, 1931, and accordingly no invitation shall be issued to the public to subscribe for any shares or debentures of the company.

SHARES

4. The shares shall be at the disposal of the Directors and (save as otherwise directed by the Company in General Meeting) they may allot or otherwise dispose of them to such persons at such times and generally on such terms and conditions as they think proper and provided that no shares shall be issued at a discount, except as provided by Section 47 of the Companies Act, 1931.

LIEN

5. In Clause 8 of Table A the words "(not being a fully paid share)" shall be deleted.

TRANSFER OF SHARES

- No transfer of any share in the capital of the Company to any person shall be made or registered without the previous sanction of the Directors, who may, without assigning any reason, decline to give any such sanction.
- 7. In Clause 24 of Table A the words "which is not fully paid" shall be deleted.
- 8. In Clause 25 of Table A the words "as required by Section 67 of the Companies Act 1931" shall be added to the end of the sentence after the word "refusal".

GENERAL MEETINGS

9. The Directors shall convene the Annual General Meeting and may, whenever they think fit, or when requisitioned under Section 113 of the Companies Act 1931 convene an Extraordinary General Meeting.

NOTICE OF GENERAL MEETINGS

- 10. In Clause 38 of Table A:-
 - (a) The first sentence shall be deleted and substituted by the following words:-
 - "An Annual General Meeting shall be called by at least seven days notice"
 - (b) The first fifteen words of the second sentence shall be deleted and substituted by the following words:-
 - "All extraordinary general meetings shall be called by at least fourteen clear days notice or, if greater, by the number of clear days notice prescribed in the Act or these Regulations in relation to the business or resolutions to be considered thereat".

PROCEEDINGS AT GENERAL MEETINGS

- In Clause 40 of Table A the words "at the time the meeting proceeds to business" shall be added to the end of the first sentence after the word "present".
- 12. In Clause 41 of Table A the words", or if during a meeting such a quorum ceases to be present," shall be deleted.
- 13. In Clause 46 of Table A the words "or as a duly authorised representative of a corporation" shall be inserted before the last ten words of the last sentence.

VOTES OF MEMBERS

14. In Clause 62 of Table A the first 31 words and sub clause (a) shall be deleted and substituted by the following words:-

"The instrument appointing a proxy or evidence of the appointment of a duly authorised representative of a corporation and any authority under which it is executed or a copy of such authority certified notarially or in some other way approved by the directors may -

(a) be deposited at the office or at such other place as may be agreed by the Directors not less than 48 hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote; or"

POWERS OF DIRECTORS

- 15. (1) The Directors from time to time, and at any time, may provide through Local Boards, Attorneys or Agencies for the management of the affairs of the Company abroad, and may appoint any persons to be members of such Local Boards or as Attorneys or Agents, and may remove any persons so appointed and appoint others in their place, and may fix their remuneration. The Company may exercise the powers conferred by Sections 32 and 104 of the Companies Act, 1931, and those powers shall accordingly be exercisable by the Directors.
 - (2) The Directors from time to time, and at any time, may delegate to any such Local Board, Attorney or Agent any of the powers, authorities and discretions for the time being vested in the Directors, and any such delegation may be made on such terms and subject to such conditions as the Directors may think fit, and may include a power to sub-delegate, and the Directors may at any time annul or vary any such delegations, but no person dealing in good faith and without notice of such annulment or variation shall be affected thereby.

16. The Directors may from time to time at their discretion, raise or borrow, without the consent of the members in General Meeting, such sum or sums of money for the purposes of the Company's business as they may think fit, and may secure the repayment of or raise any such sum or sums as aforesaid in such manner and upon such terms and conditions and in all other respects as they may think fit, and in particular by mortgages, deeds of bond and security, or other charges upon the whole or any part of the property and assets of the Company, present or future, including its uncalled or unissued capital, or by the issue, at such price as they may think fit of bonds or debentures or debenture stock of the Company, either charged upon the whole or any part of the property and assets of the Company, or not so charged, or in any other way that the Directors may think expedient, and the Directors may issue debentures, or debenture stock or paid up shares to any person or persons as consideration for the purchase of any goodwill, business or property purchased by the Company.

DIRECTORS' APPOINTMENTS AND INTERESTS

- 17. A Director may hold any other office or place of profit under the Company, except that of Auditor, upon such terms as to remuneration, tenure of office and otherwise as may be determined by the Board.
- 18. The following words shall be added to the foot of Clause 85 of Table A:-

"Provided that after he has become and whilst he remains interested in any such transaction, arrangement, office or employment he shall not vote as a Director in respect of the contract or proposed contract or any matter arising thereout, and if he do so vote his vote shall not be counted. The said prohibition against voting shall not, however apply to any contract or arrangement for giving security to a Director for advances made or to be made by him to the Company or for liabilities or obligations (whether by way of guarantee or otherwise) incurred or assumed or proposed to be incurred or assumed by him on behalf of or for the benefit of the Company, or to any contract for or relating to the subscription by a Director (whether absolutely or conditionally) of any shares or debentures of the Company or of any company in which this Company is interested, and it may at any time be suspended, relaxed or removed to any extent and on any terms and conditions by the Company in General Meeting".

PROCEEDINGS OF DIRECTORS

19. The quorum necessary for the transaction of the business of the Directors shall be two or such greater or lesser number as may be determined by a majority of the Directors from time to time. Where the quorum necessary for the transaction of the business of the Directors would not otherwise be obtainable through the sickness or absence or incapacity to act of one or more Directors the quorum shall be reduced appropriately for as long as may be necessary in the circumstances.

THE SEAL

- 20. The seal shall only be used by the authority of the directors or of a committee of directors authorised by the directors. The directors may determine who shall sign any instrument to which the seal is affixed and unless otherwise so determined it shall be signed by a director and by one of the following:-
 - (a) The Secretary
 - (b) Another Director
 - (c) A person authorised by the Directors

INDEMNITY

- 21. Every Director or other officer of the Company other than the auditor shall be entitled to be indemnified out of the assets of the Company against all losses or liabilities (including any such liability as is mentioned in paragraph (c) of the proviso the Section 151 of the Companies Act, 1931) which he may sustain or incur in or about the execution of the duties of his office or otherwise in relation thereto, and no Director or other officer shall be liable for any loss damage or misfortune which may happen to be or be incurred by the Company in the execution of the duties of his office or in relation thereto. But this Article shall only have effect in so far as its provisions are not avoided by the said Section.
- 22. In Clause 118 of Table A the words "or auditor" shall be deleted and substituted by the words "other than the auditor".

AUDIT EXEMPTION

23. 




Current ownership table of organization






