

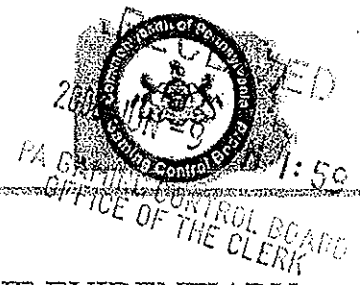
than encourage the future citizens to learn

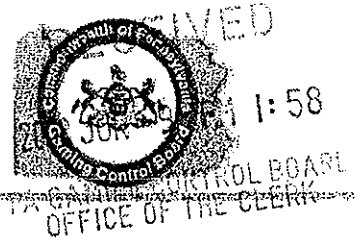
