Regulatory Oversight

The Pennsylvania Gaming Control Board is charged with promoting and ensuring diversity in all aspects of gaming activities through the establishment of regulations that promote and ensure that gaming entities foster participation and diversity in all aspects of their operation.

Diversity Participation

Each gaming entity is required to show that they contract with minority and women business enterprises to promote and ensure minority and women's business participation.

Establishment of a Diversity Plan

Each gaming entity provides a diversity plan in its application for licensure and certification that establishes a separate goal of diversity in ownership, participation, operation and employment at the regulated entity.

Report of Participation

As part of an application to renew a license and certification, a regulated entity shall file a report with the PGCB containing the following:

- Employment data;
- Number and value of all contracts;
- Number and value of all contracts awarded to minority and women's business enterprises;
- A list of each contract or transaction awarded to minority and women's business enterprises, and the actual value of each contract or transaction;
- The total number and value of all contracts awarded that contain a participation plan;
- The total number and value of all subcontracts awarded to minority and women's business enterprises under contracts containing a participation plan;
- A list of each subcontract awarded to minority or women's business enterprises;
- A comprehensive description of all efforts made by the regulated entity to monitor and enforce the participation plan;
- Information on minority and women investment, equity ownership and other ownership or management opportunities initiated or promoted by the regulated entity; and
- Other information requested in writing by the PGCB to ensure compliance with the Act.
