My name is Lori Miley. My husband and I and our 2 children live in Adams County in New Oxford. I am a Licensed Psychologist and have served Adams County since 1990.

Speaking as a Psychologist, a casino in Gettysburg would be extremely detrimental to our community for two primary reasons.

First of all, our identity will be dramatically changed. We all need a sense of identity, who we are as people, and a community develops its own identity as well. Gettysburg is a historical town that is loved by many around our nation. We have a rich heritage here. We are a family-friendly environment Gambling and the Adult Entertainment Industry is not our current identity, but if the casino is implemented it will become our identity. This will be a huge psychological blow to our county and even to our nation. A casino does not belong beside a national historical location. If you vote for the casino, Gettysburg will lose its sacred historical value and we will be known as a gambling town.

Secondly, the social effects of a casino in a small town are too great. The number of Pathological Gamblers within our community will predictably increase to over 11%. Multiple data show that there is a link between the proximity of a casino and the amount of gambling addicts in the area - The more availability, the more potential for addiction. It is predicted that this casino would bring 1 slot machine for every 14 adults in the county. This is too much availability. If this casino was in an urban area, the ratio would be much less and the impact on the community would be less than here.

Our community is not prepared to handle the associated effects of a casino. Crime will increase. Pathological Gamblers are 8x more likely to be arrested. (Such arrests are for fraud, theft, disorderly conduct, spouse abuse and alcohol & drug abuse.) Our current law enforcement and judicial system will not be adequate enough to handle this change. Tom Stoner, a local doctor, strongly asserted that Gettysburg Hospital will not be capable of handling the increased medical needs. (Pathological Gamblers have twice as many physical and mental health problems.) The emergency room will have a much longer wait time. People will not be served adequately.

Families will be torn apart. Pathological Gamblers are 3x more likely to get divorced, 5x more likely to declare bankruptcy, 3x more likely to be fired from their jobs. 11% of our community is equivalent to 8000 people. Many of these will experience great financial ruin. Depression and low morale will be prevalent. Gettysburg will no longer be an attractive place to raise families, and good families will move out of our area.

Abraham Lincoln stated that this is "hallowed ground". If you allow this casino to come, America will lose this very special historical place. It will no longer hold the quality and character that makes it so special. Gettysburg will be forever changed. You have a moral obligation to listen to Adams County citizens and to America. The vast majority do not want this casino here. Please listen to us and find a more suitable location for this casino to go!

I'm not sure that any Civil War historians would share my interpretation of what happened here 143 years ago. But, living in Cashtown, I may have a slightly different take on the Battle of Gettysburg than other more sophisticated scholars. I think it was an accident. I won't go into the details that lead me to that conclusion, because I don't really want to talk about that accident in particular. I really want to talk about another accident that may be just around the corner.

The word "accident" itself comes from ancient roots that indicate that something "happens" or "falls on" someone.

OYER

And I am worried now that the prospect of a Casino may fall upon this community. The accident that fell on this place 143 years ago sealed the fate of the town as a historical memorial—a powerful reminder of one of the most significant events in American history.

If a casino complex is allowed here, it will again seal the fate of this community, this small historic town, and turn it into an overcrowded enticement for people looking for entertainment that is different from the educational and heritage experience that millions of people have already found here.

I think No Casino has mustered a tremendous amount of evidence derived from experience in other casino venues.

I trust that the Board will pay some attention to that research that anticipates the effects on this community—the expected and even the unexpected consequences of a casino in this historic place.

Gettysburg's fate was sealed 143 years ago by an accident of history, and I am worried that what the Gaming Control Board may decide to do will re-define the fate of this memorial town that is in its own right a small place but by no means quaint.

This is an interesting community, full of variety in culture and population. A casino here would radically change what this area is and has been—and should be. And I fear the consequences. I know that many people who moved here came to GETTYSBURG—that small, but not so quaint historic town. Many will feel disappointed and even betrayed if they wake up some morning and realize that their new—and old homes—are now surrounded by a different culture.

The easy argument in favor of licensing a casino in this place is that it is "only a business." But a Casino is not "just any old business." It is a special kind of business that many of us fear will have consequences so unpredictable that responsible citizens are resisting it.



WRITTEN COMMENTS FOR EVIDENTIARY RECORD OF THE PUBLIC HEARING BEING HELD IN GETTYSBURG ON MAY 17, 2006 BY THE PENNSYLVANIA GAMING CONTROL BOARD

BY DR. WALTER L. POWELL

Chairman Decker and Members of the Board:

I would like to thank the Commission for the opportunity to offer testimony. I reside with my wife and family in a house located in Straban Township—just a mile from the site of the proposed casino. Since moving to Gettysburg nearly 30 years ago, I have closely watched and commented on many developments that have had an impact on Gettysburg National Military Park, and I can think of nothing more incompatible with all that Gettysburg has come to represent to the American public than the proposed slots casino. While the applicants, Chance Enterprises, are to be applianded for seeking to improve employment opportunities in Adams County, this proposal is entirely inappropriate, for the very nature of the enterprise constitutes a symbolic dagger aimed directly at one of America's most historic and symbolic shrines—the Gettysburg Battlefield. Whatever might be said of games of chance and associated entertainment, the reality is that the American public does not believe these activities should be directly associated with Gettysburg. As a Civil War author and historian, and as past president of the Gettysburg Battlefield Preservation Association (1990-2001), I have received numerous personal inquiries—all of them expressing opposition and concern. Furthermore, virtually everyone I have spoken to in my community—friends, neighbors, professional colleagues—are adamantly opposed.

History has a way of repeating itself, and perhaps this illustration might be instructive. In 1892 a group of investors headed by Edward M. Hoffer of Hummelstown, Pennsylvania sought to construct an electric trolley linking downtown Gettysburg with the key landmarks of the Battlefield. These investors argued that the trolley would offer economic benefits and promote tourism. Local opinion was divided, but Gettysburg -Borough Council President William H. Tipton, a prominent local photographer and businessman, actively promoted the project, and convinced Borough Council to provide the critical access to Borough streets that the Company needed. Once the actual construction began in the Spring of 1893, however, those veterans visiting the Battlefield were outraged. As Gettysburg historian Tim Smith has noted, "veterans from Philadelphia complained that they could not "find words in the English language severe enough to censure the authorities of the city of Gettysburg in allowing money-making vandals to mar the sacredness, the beauty and romantic features of the place." The overwhelming reaction of Union veterans was negative, and their lobbying soon prompted the War Department, Congress and President Grover Cleveland to get involved. Ultimately the Government asserted its right of eminent domain—an issue decided in favor of the people of the United States in the landmark Supreme Court decision of January 27, 1896 (U.S. v Gettysburg Electric Railway Company).

Dr. Walter Powell-testimony--2

While no Civil War veterans can weigh in today, clearly we have on public record their views about inappropriate commercial development on or near the Battlefield, and their descendants and many others have come forward to express similar concerns about the Chance Enterprises application. Economic development is necessary, and growth in Adams County is inevitable—but surely the nature of that growth must be measured against the incalculable damage in might do to the sense of "Sacred Space" that defines the Gettysburg Battlefield. We sincerely thank you for this opportunity to comment <u>AGAINST</u> building a Casino near Gettysburg. I have been authorized to represent our nine Board Members, sixteen Staff Members and forty-two residents.

I am not going to make this long, for you have already heard most all of the passionate and very valid arguments as to why a casino should not be built anywhere near Gettysburg. Comments like protecting the heritage of this nation and the blood stained sacrifices of those who fought that great Civil War battle here. As a Supervisor, for Mt. Joy Township, Adams County, I'm concerned the provisions of the current law do not provide for equitable sharing of costs related to traffic and other adverse impacts on those townships adjacent to the township in which a casino may be located.

Mt. Joy Township, adjacent to Straban Township, has State Route 97 as a main artery between Maryland and Pennsylvania. I expect this road to be heavily traveled by visitors to the proposed casino in Straban Township. Especially since the promoters of the casino have stated their outreach area includes Maryland.

Internal connecting township maintained roads leading to Straban can be expected to receive increased traffic resulting in increased maintenance costs which are currently not able to be off-set by revenues from the casino. This is inequitable; it is actually a "casino tax" upon the residents of the adjacent township.

As a resident and educator in Adams County and a Gettysburg College graduate, I feel compelled to submit my comments in opposition to the Chance Enterprises slots license application for "Crossroads Gaming Resort and Spa" in Straban Township, Gettysburg. I am opposed to this proposal for a number of different reasons: location and its effect on historical integrity and preservation of the battlefield and surrounding community; fiscal and social well being of our residents and community members (especially as this impacts young people and their families in a rural/small town region); the premise that slots and gambling profits are a results of other individuals' financial losses.

A slots parlor would greatly detract from the historical significance of this area as a pivotal moment in the Civil War. The eyes of our nation and the world are focused here now, waiting to see if we will permit profit to trump the commemoration of valor and sacrifice. While some may argue that the bravery of our fellow Americans, our ancestors, is enshrined physically on a Civil War battlefield and that the slots parlor is "nowhere 'near' the battlefield," it is important to note that the remembrance and recognition of these soldiers' deeds permeate the atmosphere and attitude of an entire community, far beyond the official park "boundaries." This community lives in the present yet reveres the past, a duty and an appropriate response for the residents of one of America's national treasures. In addition, Gettysburg is the most northern point of the Route 15 Historical (and Endangered) Corridor, which extends from Gettysburg south to points of significance in Maryland and Virginia. We need to help by limiting new development - a slots parlor would, unfortunately, undermine this kind of preservation.

With so many factors competing for students' and families' commitment and attention to education, the many and potential disruptions that slots would present in a small town like Gettysburg could have a far-reaching and negative impact on school life and learning. Whether it be the upheaval of a family dealing with a problem gambler or a high school student with a part-time job exposed to the atmosphere of gambling at an early age (too young to discern these aspects realistically), the risks and the effects on daily performance by students of all ages (attendance, stress levels, focus, achievement, participation in extra-curricular activities, etc.) are unpredictable yet potentially devastating.

Finally, this community has always been a nurturing, safe, clean and healthy place in which to live, learn, grow, work, recreate, and take in cultural and historical experiences. As "America's Small Town" to the rest of the world and as "home" for those of us fortunate enough to call it that, I believe we can develop more positive and lucrative means by which to sustain our community economically than depending on the financial losses of casino patrons (some of whom may be susceptible to gambling addictions, etc.) to "earn" a profit.

A slots parlor in Gettysburg is incongruous with the tourism, economic, community and historical characteristics of this town and the larger area of Adams County.

I have been an internal medicine physician in Gettysburg for 25 years. For all of these years, I have had an active hospital practice at the Gettysburg Hospital. Along with my partner. I have cared for the majority of the medical patients admitted to the hospital and most of the unassigned patients-patients who require hospital care but have no local physician. Most recently, I have been working an average of 60 hours/week due to the shortage of physicians in our area. Recruiting additional physicians has been difficult in part due to the lower income caused by high overhead costs in Pennsylvania and the large work load required in order to provide for the needs of our community.

A casino complex would most likely bring more unassigned patients to our small hospital We do not currently have the medical resources available to care for a significant influx of patients. The physicians who do move to Gettysburg and stay do so because they are attracted the small town family oriented community. That is the one thing we have to offer that many other places do not. A casino would change that atmosphere and I believe make it even harder recruit qualified hospital physicians now and in the future.

Therefore, I encourage the Pennsylvania Gaming Control Board to DENY Crossroads Gaming and Chance Enterprises a license for a slot casino in Gettysburg.

There are other parts of the State which would better meet the legislature's intent and the will of citizens who can welcome a casino and all which accompanies it. What cannot find a different home is Gettysburg and its history. Adams County won't be able to absorb the influx and retain its character of the good old days — before 2006.

It seems that supporters are weighing only the promises and predictions of economic benefit. But the majority of opponents' arguments concern quality of life issues. When Gettysburg Borough Council's president testified before you on April 5, 2006, he explained Council's casino support (6-3) in blunt terms: This is not a moral issue. This is an economic issue. I join with all who ask, When is an economic issue not a moral issue?

One might wonder if Borough Council members soon ended up truth of this question: During its meeting before the April 5 PGCB hearing, after Chance made a last minute offer to fund Gettysburg \$1 million a year, Council voted to support the casino bid 6-3. Several weeks after the hearing, we learned that Council members finally had read the fine print only to be astonished that the investors had strings attached to the deal. Reportedly, there could be years when Chance won't budget that cool million.

This, I suppose, is the risk of entrusting investors with the power to deliver on the economic promises they've temptingly used to secure support during the licensing application period. The breadth of Chance's accumulation of power is worrisome: The investors — only one of whom lives in Adams County — have promised funding to some local government, country agencies, and organizations in exchange for support — or for silence from opponents who fear risking future funding from the casino owners or, if the bid is denied, from the two investors who have been involved in philanthropy in the County. It seems unwise that 10 casino owners would have that kind of power and influence over the economy and life of one county. Especially when the majority public opinion does not want to live in the shadow of the culture of a casino.

Supporters are willing to risk the issues of economics because money is the goal. Opponents recognize there is an economics to quality of life which must not be risked. That which gives life its spirit and value cannot be bought; nor can it be refunded when the community is sorry that a casino has consumed the economics of quality of life. This soul and sense of a greater community can, however, be squandered by supporters of the kind of business which does neither suits Gettysburg nor is worthy of its respected name.

While supporters expect PGCB to look only at the economic issues, opponents must trust the Commissioners to weigh the value of location against the non-refundable cost of changing and harming the pricelessness of the qualities of family life within a unique little town in a peaceful, pastoral little county. I hope that the PGCB will have the wisdom and foresight to recognize that a license for a Gettysburg site is inappropriate as a governmental or business decision. It would be inappropriate historically, culturally, infrastructurally, environmentally, and ethically.

Thank you for considering why a casino is wrong for Gettysburg. We and Gettysburg's soul are in the hands of the PGCB commissioners.



Dear Voting Members of the Board:

In championing their Crossroads Casino, Chance Enterprise has made much of the benefits that casinos have brought to Vicksburg, Mississippi. At the Gaming Board Hearing on May 17, Larry Gawronski, President of the Vicksburg Convention and Visitors Bureau, testified on behalf of Chance Enterprises and challenged everyone in the room to visit Vicksburg and see for themselves how wonderful casinos can be for a community. In March 2005, before Chance announced plans to build a casino in Gettysburg, we visited Vicksburg as part of a driving trip through the Southeast. We expected to find a downtown similar to Gettysburg. That was not the case.

Our appreciation for Gettysburg has grown enormously as the result of a cross-country bicycle trip we made in the summer of 2004. So many small towns across the country have lost their struggle to maintain a vibrant downtown and the sense of community that goes with it. Gettysburg, with its shops, restaurants, theater and historic features, is a true gem. Our recollection of walking downtown Vicksburg is much different than what Mr. Gawronski portrayed at the hearing. There were a few shops, but it was apparent that businesses are not thriving in the downtown. There were quite a few vacant storefronts and, frankly, it looked empty and somewhat depressed. There were few people on the downtown streets and our search for a place to eat ended with us getting back in the car and traveling back out along the interstate. The casinos, which we did not visit, are located along the river and down the hill from the downtown. The area between appeared to us to be somewhat neglected and blighted in appearance. It was pretty apparent that casino visitors are not spending their money in downtown Vicksburg.

Mr. Gawronski also spoke of the decrease in the unemployment rate from 8% to 6.9% which he credited to the casinos. With such a high rate of unemployment, one can understand that Warren County would welcome any kind of economic development. With an unemployment rate of 3.3%, Adams County is an entirely different economic environment. Adding thousands of unskilled, parttime jobs to our economy and the workers to fill them may, over time, result in a rise in our historically low rate of unemployment. Adams County is the third fastest growing county in Pennsylvania. What we need are better jobs, not more jobs.

We have something very special in Gettysburg. It is special to the people who live here and it is special to the Commonwealth which benefits greatly from its tourist dollars as a historic destination. Adams County already has more growth than it can handle and a low unemployment rate. We don't need the jobs, we don't need the development and we certainly don't need to have the life sucked out of downtown Gettysburg. We all lose if Gettysburg ends up like Vicksburg. Why risk the loss to us and to Pennsylvania when you can locate a casino somewhere else.







Thank you for this opportunity to comment on this application. I am unable to attend the hearings.

I think there is a concept that has been missing in the discussion so far, in that no one has demonstrated a comprehensive understanding of the forces that will affect property taxes in Adams County, especially within the area around the proposed location. Crossroads does recognize the possibility that property values will rise, and I'm sure that they consider that a good thing. However, there is another edge to that sword.

When property values rise, will the county commissioners resist the temptation to increase assessments, and the resulting taxes? NO! The idea that the slots revenues will offset these taxes is absurd. It will be years in the future, if ever, until we see results that matter. The revenue is currently being promised – already Gettysburg Borough has been promised a million dollars by Crossroads in return for their support. So, they supported the project on Wednesday and two days later, on Friday, the Borough was complaining about the increased cost of police coverage – just for the hearings!!! Still, Crossroads maintains that the costs for police coverage and such for the casino will not increase!

After the state gets any money, if it does, there must be deposits in the fund until a considerable minimum is deposited. Only then will any money trickle out to other levels of government, and I do fervently believe that before any benefit reaches the individual property owner, the stream will have run dry. However much money is made – it will not be enough.

Now, the argument is that you do have a more valuable property, right? What earthly good is that? How do you pay the increased taxes? If you sell the property, you have to move out of it. Then, does it matter that in another three or five or ten years, the state thinks it will help? No, you've lost your home.

It gets worse. Possibly, you won't even be able to sell it. Would any real estate developer in his right mind pay the inflated prices, or just wait for the tax sale? History says they wait for the tax sale. Read the history from Atlantic City starting with the construction of Resorts International. We should be more intelligent than to repeat that.

Racetracks are already in the business of games of chance – they don't represent much change in the land use. That seems reasonable, and with both racing and slots – even fun! To choose a farm – regardless of the conveniently located hotels across the street – on which to locate a casino is not really an exercise in logic. I know it's zoned commercial, and I watched as the driveway for Gateway Gettysburg was relocated to match perfectly with the proposed driveway for Crossroads on the other side of route 30, and a traffic light magically appeared. What do you think that said, knowing that PennDOT wants blood and your firstborn to put in a traffic light elsewhere?

I know that the proposal includes a statement that people will come from DC, Virginia, and Maryland to gamble here. Maybe, until Maryland locates their own casinos along north-south corridors near the Mason-Dixon Line as they've been discussing. I know it failed to pass in the sine die session, but Maryland has been chafing at the loss of slots money to Delaware for years. Spend some time in Chesapeake City as I have, and listen to the outcry. There's always the next legislative session – after the election – and they could cure both problems with one vote. With gas at \$2.80 a gallon, I see no incentive to drive further north.

Last, I must point to the recent attempts of Las Vegas to create a "family" orientation, offering something for everybody – the adults who want to gamble and romp, and the children who came for the just plain fun. After telling the world they were doing this, have you noticed that they've quietly gone back to the "What happens here, stays here" adult enticement? That tells me that the proposed "something for everyone" isn't going to work in Gettysburg, either.

I'm not an Adams County native, but I've lived here for 27 years. They've been good years in a beautiful place. I've enjoyed them, and I had intended to stay, but I truly believe that I will not be able to avoid being forced out.

Attached please find the survey results I spoke of at the April 5 hearing on Chance Enterprises' Crossroads Gaming and Resort license application.

The July 21, 2005 poll was conducted by Susquehanna Polling and Research at the request of WHTM TV-27. The sample was of 300 registered voters throughout Adams County, and had a margin of error of 5.66%. The results suggest that nearly twice as many county voters oppose the license application (54%) as support it (31%).

The second poll was conducted on March 20 & 21, 2006 by Susquehanna Polling and Research. The results I'm providing to you tested the question whether more voters were more likely or less likely to vote for me based on my opposition to the slots parlor. The sample was narrower; it consisted of 300 registered Republican voters in my district (which does not encompass the whole county, only about 65% of it) who identified themselves as likely to vote in the May 16 primary election. The results suggest that twice as many Republican primary voters are likely to vote for me because of my opposition to Chance's license application (52%) as those likely to vote against me for the same reason (26%). I view the figures in the second poll as confirming and validating the results of the first poll.

I know that as an administrative agency, you are limited in the kind of testimony you can consider. When weighing community support for Chance's application, please consider this poll data as conclusive evidence of lack of community support. A slots parlor is more likely to succeed where the community is supportive.

Address to the Pennsylvania Gaming Control Board April 7, 2006 by Citizen Rich Randall, Gettysburg, PA

Members of the Pennsylvania Gaming Control Board, thank you for hearing what I have to say about the Casino at Gettysburg.

My wife and I moved to Gettysburg from Laurel, Maryland in May of 2002. We selected Gettysburg as our permanent retirement location after a long search. We visited a dozen good candidate sites over a six year period and chose Gettysburg because it had the best collection of attributes that we wanted: small town charm, rural surroundings, wonderful American heritage in the National Battlefield Park, little traffic (compared to the DC area), churches galore, great people, and a favorable tax structure for retirees on pensions. We just love this small town atmosphere.

We are proud to host friends, former colleagues, and relatives visiting our new home and to show them the sites. We really like the idea that we can help raise our grandkids in a place full of important American history. Well-maintained period buildings, rural streets, wooded glens, and farms surround the Battlefield Park. There are signs of our heritage everywhere.

We did not choose Las Vegas or Atlantic City. Now we see our community threatened a gambling hall on the edge of our beautiful town, one mile from Cavalry Field, one mile from Camp Letterman where the General Field Hospital was located in July, 1863, and just two miles from our house! We would NEVER have move to Gettysburg if we knew a casino was coming to town!



The promise that we will receive tax relief is no believable. There will be higher taxes to pay for the damage caused by the casino in the future – bankruptcies, divorces, abandoned children, etc. Well over \$900 per person per year is the predicted cost increase. And severe hardship will come – crashing down on some of our friends and neighbors who will become addicted to the slot machines. We will have to install and pay for a monitored security alarm system.

And what will I say to my grandkids as we pass the casino on our way to church? Or to get an ice cream cone? Or to go to the train station?

The details are all spelled out in this cost-benefit analysis document. But the costs for us to move again are just too high – physical, mental, and economic. We are too old to move again. We will be stuck with this thing and are very sad about it.

We feel like our peaceful retirement is going to be ruined. Thank you again for considering our input in your decision making process.



Pennsylvania Gaming Control Board (PGCB) public hearings on the proposal by Chance Enterprises to build a casino at Gettysburg

Individual speakers were allowed three minutes. I gave an abridged version of these remarks as my testimony. I am submitting my full text in opposition to the proposed casino for inclusion in the PGCB evidentiary record.

Introduction

- My name is Scott Freeman.
- · I am a resident of the Borough of Gettysburg.
- I live on Springs Avenue.
- I am an Information Technology Consultant by trade.

Thank You

- Thank you for the opportunity to be heard.
- I'm not here representing anyone or any organization other than myself and my family.

My Story

- I moved my family to Gettysburg two years ago.
- . My wife and I have three daughters ages 7, 5 & 3
- Coming from the Erie, PA area, we'd visited Gettysburg many times through the years as tourists.
- A couple years ago when my oldest daughter was ready to begin kindergarten we searched for a community where we'd raise our children.
- We researched the Gettysburg schools and found them to be ranked high in all categories.
- Gettysburg a town we were familiar with as tourists presented an idyllic living Norman Rockwell painting.
- · To us Gettysburg is, quite simply, the perfect small town.
- . It is as wonderful to live here as you would imagine visiting as a tourist.
- And we are proud to now call Gettysburg our home.

Second Ward

- I live in the borough's second ward home to two of Gettysburg's three colleges – both of whom have issued statements opposing the casino.
- At least the faculty of Gettysburg College and the Gettysburg College Parents Advisory Board issued statements opposing the casino.
- And the Lutheran Theological Seminary on the grounds of which my children play – issued a statement opposing the casino.
- Yet the three borough council members representing my ward voted on Monday (April 3rd) in favor of the casino.
- I guess they figure they know better than the distinguished faculty of these institutions of higher learning.

Gettysburg Borough Council

- Or maybe they voted in favor of the casino because of an 11th hour conditional promise of money from Chance Enterprises.
- I attended the borough council meeting this last Monday, April 3rd.
- The offer which was not disclosed to the public beforehand was so last minute that several of the borough council members hadn't even seen it – let alone had any time to review its merits in detail.
- And yet 6 of the 9 borough council members voted in favor of the casino because of the ultimatum given to the borough by Chance Enterprises – which they each cited in their remarks.
- The borough was told by Chance Enterprises to vote in favor of the casino or else forfeit any chance at future casino revenue sharing.
- And just like that a promise of money from the casino which some council members were only getting verbally secondhand – swayed the borough council vote.
- This casino which hasn't even been built or even been awarded a license yet – is already controlling our local government.
- How much stronger will that control be once the borough is dependent on the casino gaming revenue?
- If Chance Enterprises and David LeVan in particular feel so benevolent towards the borough of Gettysburg – why make the offer conditional upon a favorable vote? And why wait to make the offer until just days before the PGCB public hearings?
- I applaud the council members who rejected this conditional last minute offer: Dick Peterson, John Murphy and Marty Qually.
- Borough Council President Ted Streeter is a good man. I am not claiming he or the rest of council were bribed or that he "sold-out".
- I think the council may see the development of this casino as inevitable
 and President Streeter and council made a decision that they believe was
 the best chance to get the borough of Gettysburg a slice of the casino
 revenue. That was how I perceived their remarks which I witnessed in
 person as they each voted.
- The problem is they were clearly influenced by Chance Enterprises.
- And rather than taking a stand and proclaiming that casino gaming is wrong for Gettysburg, they erred on the side of the money.
- And I believe it was the start of a pattern that will be consistent with every future borough council vote on issues regarding the casino.

Conflict of Interest

 To me the most egregious error was councilman Bill Monahan making the claim before he voted that he had no conflict of interest even though the land for the casino is being sold to Chance Enterprises by his brother Bob Monahan who is the developer of the Gateway Gettysburg hotel complex located directly across the street from the site of the proposed casino.

- Mr. Monahan prefaced his vote by commenting that the borough solicitor had cleared him of any conflict of interest. The very fact Mr. Monahan felt the need to start his comments with that declaration shows he knew there was the appearance of impropriety.
- Mr. Monahan should have precluded himself from voting on this casino application – regardless of whether the solicitor had given him a pass.
- But instead Mr. Monahan voted in favor of the casino. Shocking!
- He must have known that the borough would take a favorable stance on the casino with a vote of 5 to 3 even if he had abstained. Instead he made the vote 6 to 3 – hoping to show strength in numbers.
- Now Chance Enterprises is using the favorable borough vote as propaganda in their ads in our newspapers claiming the borough supports the casino. It is a misrepresentation of what that vote meant.

Importance of Gettysburg

- Most historians agree: The Civil War was the most important event in US history.
- Gettysburg was the most important event of that war.
- Gettysburg was the most important battle ever fought in North America and one of the most important battles in the history of the world.
- The town of Gettysburg and its surrounding battlefield is a sacred national treasure.
- The Main Street Gettysburg website denotes Gettysburg as: "The most famous small town in America."
- I agree with that statement and would expand it to be: "The most famous and the most important small town in the American history."
- Now we are engaged in a local civil war of words debating whether that small town should forever be married to casino gambling.
- Students of history around the nation and around the world are following this casino debate.
- This is Gettysburg, Pennsylvania. This is hallowed ground.
- The State of Pennsylvania has a paramount responsibility to protect this small town because of all it represents to the State - to the Nation - and to the students of history around the world.

Lincoln Was Wrong

- I think Abraham Lincoln was wrong on one point.
- He said in his Gettysburg Address that: "we can not dedicate -- we can not consecrate -- we can not hallow -- this ground. The brave men, living and dead, who struggled here, have consecrated it, far above our poor power to add or detract."
- I think he was wrong. We can certainly detract from this hallowed ground: by building a casino on Gettysburg's doorstep.

Hallowed Ground

- I appreciate that the site of the proposed casino is not on actual protected battlefields.
- Unfortunately some businesses were built on key battlefield land before it was protected by law.
- Indeed my home on Springs Avenue built almost 100 years ago before the land was protected – is on more crucial battlefield than the casino would be.
- I do not object to development on the location of the proposed casino and
 I am not anti-development in proximity to the battlefield.
- I understand this piece of land is already surrounded by commercial and industrial developments and will be developed regardless of this casino.
- I concede some business will be built on that piece of land.
- I would certainly prefer to see us get another large manufacturer like Pella
 Windows or some high tech industry than a casino.
- The pro-casino group points out the KFC on Steinwehr Ave. near the site
 of Pickett's Charge as an example of how there has already been
 development on hallowed ground.
- It's a rather extraneous argument for the following reasons:
 - The KFC is already built. If a developer were applying for a license to build a KFC there - I would be absolutely opposed. But the KFC already exists. The battle at hand is over this casino.
 - 2. A fast food restaurant does not impact the community the way a 3,000 slot casino with a forecast of 3,000,000 visitors annually will. The global perception of the Gettysburg battlefields are not changed because of the existence of a fast food restaurant in a regrettable location - they way the world's perception of Gettysburg will change once our town is married to casino gaming.
 - 3. So do two wrongs make a right? The KFC on Steinwehr is unfortunate but do you really want to use it as an argument that because there is a fast food restaurant in a bad location we can now simply develop anything anywhere near the battlefield?
- Fast food restaurants, hotels, souvenir stands and private homes do not impact a community nearly as deeply or as detrimentally as the gaming industry will. There is no comparison.
- The battlefield has already been commercialized and in most cases it is done with respect and reverence for the battle and the men who fought and died here.
- Tourism is our lifeblood and I do not object to businesses capitalizing on Gettysburg. But casino gaming is not an appropriate companion to this sacred historic shrine.
- A casino does not reflect the values of this family-oriented community and it will not foster the reverence we should demand for this hallowed ground.

Homogeneous Economy

- I've heard pro-casino arguments that gaming would save Adams County from a homogeneous economy that is relying solely on tourism.
- Besides the fact that such statements must offend our many proud fruit growers – Adams County's other major product – our tourism trade is forever secure.
- The Gettysburg battlefields are not a finite resource like coal or oil.
- Our economy is not based on a product like automobiles or steel which can be taken away and moved to another location.
- The Gettysburg battlefield is a unique one of kind product that will always have tourism and can obviously never be moved to another location.
- The most important battle ever in North America and perhaps the most pivotal moment in American history took place right here on these fields around this town – and indeed on the streets within this town.
- Nothing will ever stop tourists from making the pilgrimage here though some surveys indicate there could be a significant drop in heritage tourism if this casino is built.
- · The homogeneous economy argument simply has no merit.
- · Gettysburg Battlefield tourism will generate revenue forever.

Adams County is not Destitute

- The pro-casino group paints Adams County as an economically depressed community starving for jobs. But the facts simply do not support this position.
- *. Chance Enterprises own Local Impact Report lists Adams County as the third fastest growing county in PA. I've seen some studies rank it second. Regardless of our exact rank out of 67 counties in PA – we are growing – and at an increasingly fast rate.
- This growth comes with increased expenses on our resources but it also provides a significant increase in tax revenue.
- Tax revenue is already increasing in Adams County without this casino.
- Adams County median income ranks 14th in Pennsylvania (source: publicschoolreview.com)
- Adams County unemployment rate which is between 3% or 4% depending on what study you cite is one of the lowest in the state.
- There must be better locations in Pennsylvania where the purported benefits of gaming can be realized without the cost of destroying the most important small town in America.
- The gaming board should look to other Pennsylvania communities that need the revenue more than Adams County.

Property Taxes

 Lowering our property taxes is the favorite argument of those in favor of the casino.

- Casino revenue in no way guarantees the borough will vote to lower our taxes.
- The borough may get some casino revenue now that they have voted in favor of the casino as required by Chance Enterprises. But will there be enough money left after covering the increased costs of all other services to provide any tax relief?
- If there is a surplus, is there any guarantee that the borough council will vote to lower property taxes?
- There is a huge disconnect between casino revenue and any guaranteed property tax relief.

Traffic

- A casino means more traffic.
- · More traffic means more money.
- But will the increase in revenue be enough and be allocated correctly to support the increase in traffic?
- Chance Enterprises own Local Impact Report claims 2.2 million unique/new day visitors.
- While a detailed scientific study is necessary to determine the exact impact this new traffic - you don't have to be a scientist to understand that this significant increase in traffic will have an impact on our current small town infrastructure.
- Other larger communities also applying for a gaming license are certainly better equipped to handle the traffic than Adams County.
- I'm not an expert. I can't speak to the traffic issues. Other studies have been and will be presented.
- I urge the PGCB to carefully consider these reports and to look past the bias and see the facts.
- And would this increase in traffic indeed mean more money for the businesses in town?
- Borough Councilman Peterson had the best point on this: He argued that
 if Chance Enterprises actually promoted Gettysburg's downtown
 businesses, it would be the first time a casino ever encouraged their
 casino patrons to spend money outside their casino.
- The proposed casino will reportedly have four restaurants. Will Chance actually send people to downtown restaurants? Seems improbable or at best an alternative that would be mentioned but not promoted.

Social Ills of Gambling

- Chance Enterprises own Local Impact Report claims: "The Applicant's
 research into potential social effects of the proposed resort indicates that
 there is a lack of a causal link between negative social impacts and the
 gambling industry."
- I also read a study the other day funded by tobacco companies which claims there is no causal link between cigarette smoke and cancer.

- You can hire "experts" to produce whatever findings support your cause.
- I'm not an expert. I can't speak to the specific rates of social ills caused by gambling. Other studies have been and will be presented.
- But any reasonable adult with the power of observation and common sense realizes the social ills that invade every community that introduces gambling.
- The facts from studies on crime, drug use, domestic abuse, divorce, bankruptcy and suicide in areas with gambling are overwhelming.
- Gambling increases the rate of all of these social ills no matter what claims Chance Enterprises makes to the contrary.
- When you think of cities where you want to raise your children, do Las Vegas, Atlantic City or any community married to gambling come to mind?

Marriage of Gambling to Gettysburg

- Gettysburg is arguably the most important historical small town in America.
- What concerns me most is the marriage of this most important American treasure to casino gambling.
- Chance Enterprises made the argument for us when they bowed to pressure and changed the name of their proposed casino from "Gettysburg Gaming" to "Crossroads Gaming."
- Why would they do this? If gaming will have such a wonderful impact on our community and if our historical treasures will benefit from this casino then why change the name?
- Why not proudly proclaim the casino as what it is: the "Gettysburg Casino?"
- The answer is because even the applicant concedes that the marriage of Gettysburg and gaming do not play well on the local or national stage.
- The very name "Gettysburg Gaming" was offensive to the residents of our small town and to students of history around the world.
- You can divorce the name "Gettysburg" from the resort. But if this casino
 is built, you will never be able to divorce gaming from Gettysburg.
- Right now when people think of Gettysburg they think of history and of a charming guintessential small town.
- After the casino is built when people think of Gettysburg they will think of history AND gambling – in the same way people automatically think gambling when they hear the name "Las Vegas" or "Atlantic City."

The Character of Our Town

- · The face of Gettysburg will change.
- · Quaint antique shops will become pawn shops.
- · Souvenir shops will become adult entertainment venues.
- Our charming historic brick store fronts will become littered with flashing neon signs.
- The heart and soul of Gettysburg will change.

- Our historic small town charm could be forever lost.
- Currently this is a destination for history buffs and people who love the agrarian countryside.
- We're going to replace that target audience to become a destination for gaming and people who love the flashing lights and sounds of a casino.
- Do those groups overlap? Do some history buffs gamble? Do some gamblers love history? Certainly. But largely they are different crowds of vacationers.
- Just look to Atlantic City or Las Vegas and you will see very different crowds than the crowds in the Gettysburg town square on any given day.
- Just compare the marketing campaigns for those respective areas and clearly they have very different target audiences.
- I live on Springs Avenue just blocks from downtown. I walk my children down to the town square every weekend in the summer for ice cream.
 The people we see are overwhelmingly families with school-age children.
- The casino crowd is different indeed, you have to be 21 to gamble.
- Chance Enterprises Local Impact report claims: "Chance Enterprises, Inc.
 will create a unique upscale recreational destination in Adams County that
 helps build the economy, respects, preserves and promotes the region's
 history and culture and supports a healthy community for people to live,
 work and raise their families. There is no intention to have the facility
 appear as a glitzy casino with gaudy or garish lights and signage."
- Will the casinos that will follow, however distant in the future that may be, make the same promise? And will Chance Enterprises or other casino operators keep that promise? That is definitely a gamble.
- It won't happen over night. It won't happen in a matter of years. But elected officials will change, political priorities will change, laws change, signage ordinances will change. The face of Gettysburg will change.
- Future generations my daughters' generation will know a very different Gettysburg.
- The charm of this quintessential small town will be lost.

Cost of Success

- I actually think the casino would be successful in terms of generating revenue. Casinos generate revenue and that's why the state of Pennsylvania is pursuing gaming licenses.
- Every study and report claims different amounts. Bottom line is: We don't know how much. But a casino in Gettysburg would generate revenue.
- I've read all of the posted studies -- those by Chance Enterprises and counter arguments posted by the opponents.
- I'm not an expert. But make no mistake all numbers are forecasts and theories. The purported revenue from gaming is itself a gamble.
- Who would benefit most? And would Gettysburg generate more revenue than other proposed gaming locations? Those are questions I cannot answer.

- But I can tell you this revenue will have a cost.
- The more successful a casino in Gettysburg is, the greater the failure of this community would be.
- One successful casino will bring more casinos no matter how far in the future that may be.
- I firmly believe, based on the various surveys that have been conducted and on my own conversations – that Adams County residents are overwhelming opposed to this casino.
- I further believe that if you asked the question: "Would you oppose 3 or 4 casinos built near Gettysburg?" rather than "Would you oppose a (one) casino built near Gettysburg?" then the number in opposition would be even greater.
- That is a major fear of this community that one casino could lead to more. And no one can make any guarantees to the contrary.
- PGCB members will change Borough council members will change township supervisors will change - priorities and political interests will become skewed by the casinos and the money involved.
- The more successful this casino is the more probable it is that future legislators a generation from now will approve additional casino licenses.
 It is a slippery slope that could lead Gettysburg to become a full-blown gaming community.
- The casino money will come to rule the town.
- · The money from the casino will infect everything.
- It already has! This proposed casino hasn't even been awarded a license and already the borough council conceded to the pressure of 11th hour verbally promised casino revenue.
- If this casino is indeed a big success it will become the 800-pound gorilla in the room - that gets whatever it wants.
- Gettysburg's political interests and business interests will begin to center around the casino rather than around the battlefield.
- Rather than a dedication to battlefield preservation driving borough council decisions - the revenue from the casino will influence everything.
- THAT is how it hurts the battlefield. THAT is the cost to this town.

Stars in Their Courses

- In my humble opinion the greatest book ever written about the Gettysburg campaign is author Shelby Foote's narrative titled Stars in Their Courses.
- And if you read that book you come to understand the title means fate brought the battle here to Gettysburg in 1863 - it was unavoidable - like stars in their courses.
- And I think it was inevitable that nearly 150 years later this battle over a proposed casino would come to Gettysburg - like stars in their courses.
- This town survived the previous battle because as destructive as it was for those three days - the battle was finite - lasting just three days - then the Confederates left.

- I don't think we can survive the casinos because once they are here they will be here to stay.

Closing

- I was optimistic after the Pennsylvania House of Representatives unanimously (199-0) passed an amendment (3/14/2006) that would prohibit the proposed slots casino in Adams County.
- But after the borough council vote 6-3 in favor of the casino on Monday April 3rd, I am now pessimistic that this casino can be stopped.
- The difference between an optimist and a pessimist is that the pessimist is better informed. We've been reading for months now in the papers that David LeVan is a close personal friend of Governor Rendell.
- I have now witnessed in person how the promise of money can influence our local politicians.
- I know many Adams County residents I speak with feel the casino is already a done deal. Perhaps that is an explanation as to why more residents are not getting involved and mobilizing in opposition.
- But if this casino is approved and if the face of Gettysburg is changed forever – when my children and grandchildren ask me: "Why didn't you do something – why didn't you get involved – why didn't you voice your opposition." I will be able to tell them: "I did." I did stand up and speak my piece at the forum that was provided.
- I guess we'll see if my voice and the thousands in concert with me made a difference.
- The world will little note nor long remember what I say here. I'm just one
 citizen with one vote expressing my personal concerns. But the world is
 watching and judging Pennsylvania and it will never forget what decision
 this gaming board makes.
- I'm asking the PGCB to deny this applicant's gaming license request and to allow Gettysburg to continue to be the living Norman Rockwell painting that we knew when we moved here.
- Thank you for your time and for the opportunity to express our concerns.

As a footnote – to support my testimony regarding the borough council vote – here are a couple excerpts from local newspapers:

- Gettysburg Times Tuesday, April 4, 2006: "Council member Dick Peterson vehemently opposed the casino. 'I am emphatically opposed to a casino in our area,' he said, 'and I will not be bribed into thinking otherwise. The deal was not on the table at the council's regular meeting Wednesday night. Chance Enterprises made the apparently sudden offer to guarantee \$1 million annually to the borough."
- Hanover Evening Sun Tuesday, April 4, 2006: "And after the meeting, Streeter wouldn't say the agreement was predicated on positive testimony. Instead, he just said he thought the borough was positioning itself for Chance to look favorably when considering whether to compensate Gettysburg for the increased traffic and other costs a casino could bring. 'If I were Chance, I would look less favorably on granting the borough money (if we'd testified against the proposal),' Streeter said. But Chance CEO David LeVan said outright the grants were offered for favorable testimony. Casino opponents argued such grants should not be conditional on testimony. 'To support a proposal based solely on financial reward is to invite charges that the Borough of Gettysburg is for sale,' (council member Marty) Qually said before his vote against supporting the casino. Chance began brokering the grant agreement following a meeting called to gather public comment Wednesday, LeVan said. Many council members voiced concern at that meeting the borough wouldn't get any funding, while Straban Township and Adams County would. The grant money would come from Chance Enterprises' profit, in addition to money already taken out for governments through the legislation authorizing slots, LeVan said. At Monday's meeting, many council members said they hadn't seen the agreement, and Qually said borough Solicitor Harry Eastman hadn't been able to thoroughly review it. The agreement has not been made public. But with the borough's Wednesday testimony approaching, the majority of the members said they were willing to trust the agreement without further scrutiny because of LeVan's reputation as a philanthropist and community benefactor. "

The Lincoln Highway in Adams County is part of a 200-mile Roadside Museum created by the Lincoln Highway Heritage Corridor, a state-supported heritage area in the Commonwealth of Pennsylvania. The organization is part of the Pennsylvania Heritage Areas Program, under the Department of Conservation and Natural Resources.

The roadside museum interprets resources associated with the Lincoln Highway and the more than 200 years of regional transportation history that preceded it. In Adams County interpretative sites include Historic Hotels and Inns, Railroad Stations, The Fruit Belt and two recently created Murals.

A 200-mile Roadside Museum requires that people be able to travel the road to access the interpretive sites. In Adams County any additional traffic on Route 30, primarily a two-lane road, will make it more difficult to travel the route of the museum. Driving through the area east of the Borough can be difficult and more traffic from the proposed Casino will only make it more challenging.

The Lincoln Highway Association is a national non-profit organization that is dedicated to preserving and promoting America's first transcontinental highway for the automobile. The organization is a continuation of the original Lincoln Highway Association that formed in 1913 to promote the development of this road.

The Lincoln Highway crosses 12 states as it makes it way from New York to California. I serve as the State Director for Pennsylvania, which has always been a very popular section of the Highway because it still contains so many of the early roadside attractions – hotels, old gas stations, diners, restaurants and even a few oddities such as The Shoe House in York and The Coffee Pot in Bedford. The area around Gettysburg is an important piece of the highway story.

It is becoming increasingly difficult to travel the highway and remain on untouched, pristine sections of the highway. In so many places, the modern world has intervened, destroying original alignments of the road and taking many of the historic structures with it.

The changes that would be required to allow the Gettysburg casino to accommodate its customers would destroy even more of this already-threatened historic road. If you can no longer drive the highway because it has been destroyed, by-passed or changed significantly is to lose the very essence of the experience. It is becoming harder and harder to drive the highway without traveling through sections that no longer convey its story.

As preservationists, we are often asked to "make exceptions" in the name of progress or development. We are told that in this particular instance, the end result is a greater good and that this is only one small loss of one small section of the highway. Unfortunately, each time a new threat is brought to light, the same argument is used; one small loss for the greater good. But I say, "NO." Each time we agree to another "small loss," we are eroding our history. If we say yes too many times, there will eventually be nothing left!

The Lincoln Highway Heritage Corridor is a nonprofit organization working along the historic Lincoln Highway (Route 30 for the most part in PA) in Adams, Franklin, Fulton, Bedford, Somerset, and Westmoreland counties. Our organization has no governing or regulatory role, but our mission is clearly the preservation of scenic, cultural and historical resources, as well as the restoration and development of existing and new programs and facilities along our 200-mile Corridor.

The Lincoln Highway Heritage Corridor joins many other state agencies, regional planning commissions, and local residents in promoting sound land use policies. This does not mean that open space preservation practices are 'anti-growth'. Each community has its own economic development needs and one-size does not fit all. This is why it is imperative that planning commissions incorporate conservation design into their comprehensive plans, and include standards to ensure that new development proposals will be designed around the principle of land conservation.

Six years ago an Adams County Steering Committee approached the Lincoln Highway Heritage Corridor with a request to become part of the existing five-county heritage area. The Committee was comprised of almost two dozen individuals representing a cross section of Adams County businesses, civic, government (at all levels), and individuals. Several goals/issues emerged from this feasibility study. Related to this topic, the Adams County Steering Committee aspired to:

- Be an advocate for the preservation of community character and scenic views along the historic Lincoln Highway in Adams County
- Encourage efforts to enhance scenic views
- Preserve and enhance critical viewsheds
- Formulate guidelines that encourage high standards of design for development projects that front on U.S. Route 30

Pennsylvanians (especially Adams County residents) enjoy a high quality of life; nothing should jeopardize this. There is a 'sense of place' in Adams County; it must be protected, even as development occurs. Don't straddle the fence!
