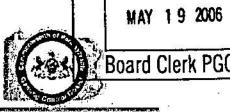

Thank you for your correspondence of April 13th inviting me to comment at the recently held public inp hearing. I regret scheduling did not allow for my personal appearance, but ask this correspondence, encouraging issuance of a gaming license to Mount Airy #1 LLC, become part of the public record.

My roots and family are in Pennsylvania. I was born and raised in the Poconos and grew up less than a mifrom the Mount Airy site. I spent the majority of my adult life as a practicing attorney in Monroe, Lackawanna at Luzerne counties. More specifically, my legal career changed when I accepted a position as counsel to my family former business, Mount Airy Lodge, Inc., previous owner of the resort. I presently live in Florida.

John and Suzanne Martens founded the original Mount Airy Lodge in 1936 and their heirs owned at operated the business into the 1990's. Having been born and raised in the Pocono resort business, I hope resperience and following comments represent a unique, insightful perspective of the Pocono resort industry at how its first gaming license can most effectively benefit the community.

The Poconos have experienced significant changes to its image and identity throughout the years. In t earlier part of the last century, the Poconos enjoyed prosperity as a country destination spot where people from t cities went on extended vacations. Before the interstate highway system, it would take a matter of hours to get from New York City to Mount Pocono. The typical length of a customer's vacation stay was often measured in weeks as sometimes months.

Throughout the 60's, the Pocono resort industry gained momentum as improvements to highways a transportation facilitated access to the mountains. This led to inevitable changes in marketing strategies employ by various resort owners, some of whom continued their business identities as country resorts. Other resort owner introduced "heart-shaped" and "champagne glass" bath tubs promoting honeymoon tourism. Still others introduce a vague new concept to the industry known as 'timesharing'.

The result of these efforts sparked a growing desire by the public to purchase a vacation home instead staying at a resort. Fewer customers began frequenting resorts for shorter stays. Developers capitalized on a buildi boom and the population swelled. When these purchasers discovered the cost of living was cheaper than in t cities, the Poconos were treated to something new. The commuter.

Fuel then was dramatically cheaper and the Poconos became a bedroom community. Thus, most peo commuting from the Poconos can trace their residency to the resort community and real estate developmen spawned.

As more people relocated, school districts were burdened with additional students and a need for large facilities. The revenues to achieve this were derived from taxes on real estate. The resort industry was particularly hard since large tracts of land are inherent to the business. Meanwhile, nothing was achieved to sect taxable income from commuting residents to offset the growing public cost. School districts raised mileages, form resort customers lived in their "vacation" homes, business slowly dried up and several resorts shut down.

It is perfectly understandable why commuters relocated members of their extended families to the Pocor where more children could occupy a single dwelling and a family could reduce its cost of education. Yet, hospital law enforcement, emergency response and other public services also felt the burden.

Now that the legislature has legalized gaming, the Pocono resort industry, more than ever, is poised resurrect, maintain and expand the business it had lost. A strong recovery and continued growth of Pocono touri is vital to economic strength and stability in the region.

There recently have been some encouraging developments in the local resort industry with the construction of Great Wolf Lodge and the acquisition of Camelback ski area. However, the Poconos desperately needs to build 'image' based on a clear identity as a desirable choice for a vacationing public with higher expendable income. The image is equally dependent on attracting a labor force capable of providing the required services. It must a compliment the nature of the community and emphasize a higher quality of life with superior goods and service strongly caution against pursuing trends, particularly in the casino business which nurtures the concept of "bigg meaning "better". I am living witness to circumstances and life events conclusively proving the concept unsound respectfully emphasize that "quality", not quantity, must emerge as the overall premise guiding this historenaissance.

As to labor, "employability", not "job security" must be the concept encouraging development of a mothighly skilled labor force. People need to know they can be trained, suitably paid, enjoy a higher quality of life a advance themselves personally, professionally and academically. Demands for higher quality and lower cost a nothing new, but no business or community can be competitive without a skilled work force. Simply building mothetel rooms and hiring migrant chamber maids is not a viable strategy to achieve this goal. The strategy must designed to advance small business and the working middle class. A gaming license will generate revenue, but community unified in purpose for advancing tourism will build a future.

Gaming provides a new and historic opportunity to concretely establish the resort industry as a primary a integral part of a stable local economy. Moreover, the close proximity of large cities and major hubs transportation will allow the Poconos to seriously compete for national and international tourist trade. Prope designed and implemented, the strategy for gaming as an attraction must solidify an image of the Poconos capable sustaining constant economic growth for generations. Conversely, a strategy flawed in design or inception virreparably deprive the area from establishing itself as a quality destination. Ultimately, the final decision must ron which proposal is more beneficial to the Poconos.

Though I am not completely versed in the details of each project, my following commentary is based sol upon my understanding of the issues as derived from the media and discussing this topic with family and other loresidents.

The plan submitted by Pocono Manor Investors, Inc. advertises a billion dollar investment in an 800 roc project contained in a thirty (30) story tower with grandiose plans for restaurants, retail shops and various of amenities. Admittedly, I have not seen the actual plans, but the artist rendition in the Pocono Record clear portrayed a gigantic facility reflecting a design mentality reminiscent of Atlantic City and Las Vegas. Moreover, growing public concern and opposition is surfacing and gaining momentum. Many residents are worried about the proposed size of the facility and are disillusioned why the township 'expedited' a zoning change catering to the developer's request. It is my opinion the sheer magnitude of that casino project is undesirable, particularly when

combined with growing public resentment. It does not compliment local small business nor bestow any long te collateral benefit to Pocono tourism.

The inherent nature of the complex promotes only goods and services offered by the hotel and casino. O might reasonably infer its size will deprive small businesses of customers they might otherwise attract. Will at outlet stores and restaurants benefit when the casino owners are trying to fill 800 rooms? Additionally, will the bloads of video slot and poker players look to spend money at a local restaurant when they can use their free microupon at the hotel buffet? I know something about having to fill 800 rooms in the off season when visiting to Poconos is the last thing on anyone's list. With or without a casino, an empty room costs money and a responsible to loperator will go to any length to fill the vacancy. If that becomes reality, the country inn, local restaurants a retailers will lose business.

Conversely, the plan submitted by Mount Airy #1 LLC portrays a design smaller in scale, classic and dignificant approach and intelligently suited to promote Pocono tourism. Such a plan is more desirable because it is large enough to accommodate the volume of traffic generated from gaming, yet small enough to encourage patronizity local businesses and attractions. Similarly, this plan leaves more room for the Poconos to evolve in connection with new, responsibly planned gaming facility from which tourism can be nourished. The design proposed by Mount A #1 LLC reflects dignity, charm and elegance. It is conducive to long term, stable growth reinforcing the premise that a community cannot solely depend on a single business enterprise to define its future. Rather, it must be a combine effort to develop and prosper together.

During my years in Pennsylvania, I grew to respect and admire the dedication to achievement a commitment to excellence exhibited by the DeNaples family. I have never known any of their business enterprises be conducted with anything less than a total commitment to meet or exceed the highest standards of indust Throughout the lengthy process of acquiring my family's former property and submitting plans for its futu development, the DeNaples family, their employees and representatives have encouraged bonds of cooperation we Paradise Township. More importantly however, they have clearly exceeded the expectations of many with the genuine respect for township residents and sincere desire to be a conscientious neighbor. For these reasons, I a certain a gaming license to Mount Airy #1 LLC will result in nothing less than development of a first-rate gaming resort, positively impacting the community and reviving the Poconos as a quality destination. 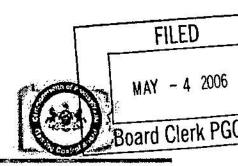

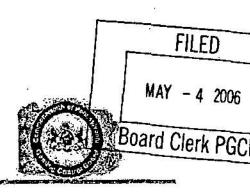

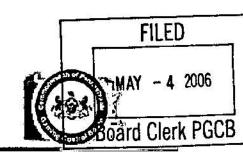

Dear Commissioners

I am writing this letter to add my comments on the applications before you. I do not know most of the applicants except by remote reputation. The one applicant I have come to know from his public life in this area is Louis DeNaples. I address my comments to Mr. DeNaples application.

Mr. DeNaples is known to me as he is to most who have served in public positions in this area as one of the quiet forces of progress and philanthropy in this community. He is the type of man who makes the difference between a community thriving or just getting along. It seems odd to describe someone as powerful and well-to-do as Mr. DeNaples as a quiet force but that is exactly what he is. I am aware of dozens of projects which would not have occurred or would have never been completed except for his anonymous (quiet) philanthropy.

Many are aware that banks now are forced to demonstrate that they reinvest in the local communities from which they receive their deposits. That program is called the Community Reinvestment Act. The bank Mr. DeNaples is associated with has always done so and it didn't take a federal law for them to see it as good business to reinvest in the local community. Mr. DeNaples quiet persuasion and commitment to the local community is also evident in the actions of his bank.

The gaming process has attracted many out-of-state interests who see a great opportunity to make money in Pennsylvania. Clearly, if those out-of-state interests offer the best proposals, they should be chosen. But I cannot help but notice that the same qualities which have governed Mr. DeNaples entire life have been evident in how he has worked with the potential host community in this application. He has the local community working with him precisely because he works with them. He has not proposed a project which, while it might sound impressive, is probably too large to be economic and is opposed as is the proposed project at Pocono Manor. Those who have seen hotels larger than 250 rooms close and remain derelict in the local community would naturally question what is proposed at Pocono Manor. A

gigantic, spectacular failure is in no one's interest. Mr. DeNaples proposes 200 rooms and we see hotels of that size such as Skytop thriving, while the larger ones have most often failed.

Louis DeNaples was quietly helping to build and complete important public projects all over this region for years before this project could ever have been contemplated. His lifetime of responsible personal and business leadership in Northeastern Pennsylvania should be weighed very heavily in the Gaming Control Board's decision-making process.

I believe that Mr. DeNaples should be awarded one of the licenses. His proposal is appropriate and responsible and he has demonstrated his commitment to this community over his entire lifetime.

GOOD MORNING AND THANK YOU FOR THE OPPORTUNITY TO ADDRESS THE GAMING BOARD.

MY NAME IS JOHN T. FLANAGAN, AND I PRESENTLY SERVE AS THE BUSINESS MANAGER AND FINANCIAL SECRETARY FOR THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS LOCAL UNION #81 (IBEW 81), WHICH IS BASED IN SCRANTON, PA. LOCAL #81 HAS JURISDICTION OVER ALL OR PART OF EIGHT COUNTIES IN NORTHEASTERN PENNSYLVANIA. THE AREA OF MONROE COUNTY, WHERE THE TWO APPLICATIONS FOR THE CASINO LICENSE ARE BEING REQUESTED, IS IN THE JURISDICTION COVERED BY IBEW LOCAL #81.

HOWEVER, I AM HERE TODAY AS A REPRESENTATIVE OF THE

SCRANTON BUILDING TRADES COUNCIL, OF WHICH IBEW 81 IS AN AFFILIATE.

I WOULD LIKE TO ADDRESS THE GAMING BOARD IN REGARDS
TO THE NEED FOR A CASINO PROJECT AND LICENSE BEING GRANTED
TO THE POCONO AREA.

I WOULD LIKE TO SPEAK FIRST TO THE DIFFICULTY THAT MANY BUILDING TRADESMEN IN NORTHEASTERN PENNSYLVANIA HAVE ENCOUNTERED IN THE PAST FIVE YEARS. WE HAVE SEEN PROTRACTED UNEMPLOYMENT UNLIKE ANY TIME I CAN REMEMBER IN MY 38+ YEARS AS A TRADESMAN.

OUR AREA BUILDING TRADESMEN HAVE EXPERIENCED LOSS OF NOT ONLY WAGES, BUT ALSO BENEFITS SUCH AS HEALTH CARE AND PENSION CREDITS. MANY TRADESMEN HAVE EXPERIENCED GRAVE FINANCIAL SITUATIONS, SUCH AS LOSING HOMES OR REMOVING THEIR CHILDREN FROM COLLEGES. MANY HAVE BEEN FORCED TO SEEK OTHER TEMPORARY POSITIONS AT MUCH LOWER PAY, AND IN MOST CASES WITH VERY LIMITED OR NO FRINGE BENEFITS. ALL OF THIS IS THROUGH NO FAULT OF THEIR OWN.

UNFORTUNATELY, THE JOBS THAT THEY'VE BEEN TRAINED

FOR HAVE NOT BEEN AVAILABLE. THE EROSION OF THE INDUSTRIAL BASE IN NORTHEASTERN PENNSYLVANIA HAS BEEN SEVERE, NOT ONLY FOR TRADESMEN, BUT TO EVERYONE ASSOCIATED TO THEIR EXISTENCE.

I WOULD ALSO LIKE TO INFORM YOU THAT BUILDING
TRADESMEN IN OUR AREA GO THROUGH A RIGID FOUR TO FIVE
YEAR REGISTERED APPRENTICESHIP, DEPENDING UPON THE TRADE.
EACH AFFILIATE AND ITS PARTNERED BUSINESS ASSOCIATION
EXPENDS A GREAT DEAL OF PRIVATE INDUSTRY MONEY ON
TRAINING PROGRAMS REGISTERED WITH THE STATE OF
PENNSYLVANIA TO ENSURE THAT AN ADEQUATE SUPPLY OF
SKILLED LABOR WILL BE AVAILABLE FOR OUR AREA. AGAIN, I
WOULD POINT OUT.....THIS IS PRIVATE INDUSTRY MONEY AND NOT
TAXPAYER OR GOVERNMENT GRANT MONEY.

THE TRAINING GOES BEYOND CRAFT APPRENTICESHIP

TRAINING AND EDUCATION. IT EXTENDS INTO ONGOING

JOURNEYMAN TRAINING, SUCH AS OSHA 10 HOUR AND 30 HOUR

COMMENTS:

The developer of Mount Airy has proved their commitment to work with and cooperate with the people and the Township of Paradise – meeting zoning, environmental and other regulations. By working within the Township's zoning laws, and in fact, being the first to use the Township's new, more environmentally-friendly sub-division design, Mount Airy "put its money where its mouth is" when it comes to being a good neighbor.

Aesthetically, the main lodge that Mount Airy proposes draws on the history and charm of the many old hotels that first brought tourists to the Poconos. The developer is preserving half of the resort's land as open space, opening it to the public, and working on trails to connect with other natural areas in Paradise and adjoining municipalities.

On the other hand, Pocono Manor has taken advantage of a small community, riding roughshod over rules that had long been in place – and which the developers knew were in place before making their plans – and insisting on zoning changes so they could meet their goals. The changes are not minor: the planned height alone of the building will make it stick out, way above the treeline, visible for miles. This may be good for the developer, but not for the rest of us who value our area's rural character for its attraction to tourists and as a place to live and work. The glass-and-palm-tree look may suit a desert resort, but is an eyesore in the mixed hardwood forest of the Pocono Plateau.

Further, Pocono Manor's plan seems to ignore a basic issue: water. Estimates suggest they will need over 500,000 gallons of water a day. Pocono Manor is located right at the top slope of the watershed – so all this water will draw on the headwaters of the area's main streams. Water is not infinite, and removing that much creates a "water deficit" – a sort of water vacuum – that pulls water from creeks and wells. At 500,000 gallons a day, how long before streams and private wells go dry? More, treating the wastewater and dumping it into Indian Run will overwhelm that small creek and destroy the natural water balance of the entire Pocono region.

The Constitution of the Commonwealth of Pennsylvania guarantees citizens the right to pure water. Pocono Manor has ignored their impact on this most basic right and has shown in its other dealings that it is unwilling to play by the rules. Mt. Airy has proved just the opposite. For these reasons, Mt. Airy's application should be approved.
