As a former employee of Seven Springs Mountain Resort I have witnessed management within the Department of Bar Service target convention groups/party events with the intent to increase company profit by fabricating customer billing; reselling already sold product from one convention group/party event to another; and selling partial bottle(s) of liquor, wine, and partial keg(s) of beer to customers at full price ratings without the customer's knowledge.

A multitude of customer billing was not presented in good faith or for good cause to the customers by Seven Springs Management. During conventions and parties I witnessed management increasing the quantity of alcohol sold to the customer on the customer's bill without the customer ever receiving the product sold. In most cases the customer could not clearly identify the correct quantity of alcohol consumed due to the large volume of guest at the convention/party event. During the customer's review of the bill the customer would sign the bill(s) having faith in "false" integrity of management.

Seven Springs Mountain Resort have implemented a system known as the J.D. Edward's System to track inventory and sales. The system established is not fully effective. I have witnessed management within the Department of Bar Service combine already sold alcohol together, (after the convention/party event left the used bottle(s)/keg(s) behind), and circulate this alcohol in the established bars/lounges at the Resort. By reselling the already sold alcohol to the general public the Department gains a second profit. The J.D. Edward System doesn't track these transfers due to flukes in the system.

During conventions/party events Management would often give the customer partially empty bottle(s)/keg(s) and bill the customer full price. The keg(s) were always tapped outside the customer's presence and the bottle(s) served by Seven Spring's Staff. The customer would sometimes question the amount sold, but Management would reassure them that it was the correct amount. Giving the customers partial bottle(s) and keg(s) is a common practice for the Department of Bar Service.

A formal notification was given to Human Resources and Higher regarding the unlawful acts within the Department of Bar Service. To my knowledge the Resort has not put forth a reasonable effort to investigate any claims. Please consider an investigation before allowing this company to secure a State granted slot machine license.

Dear Harold:

This letter is in response to your letter received on March 30, 2004, regarding your employment status with Seven Springs Mountain Resort. On June 26, 2003, you informed the Bar Service Office that you had accepted full-time employment elsewhere, and that you could no longer work for us as a full-time employee. However, you did ask if it would be possible to work part-time on weekends.

Bill Aldom, Bar Service Director, agreed to change your employment status from full-time to part-time, stipulating there was no guarantee that additional temporary part-time weekend work would be available after the summer, even then only as long as your new job did not limit your part-time status for Seven Springs Mountain Resort.

The Bar Service Department was able to extend part-time work to you on weekends through October 18, 2003, to assist with Autumnfest. Due to the economic conditions and the reduction in part-time labor needed within Bar Service, the Bar Service Department was unable to continue your part-time work status past the end of October on weekends only.

The Bar Service Office did offer you the opportunity to work during the week after Autumnfest, when part-time work became available. However, when these schedule requests occurred, you stated that you were not available. After turning down these offers for work, the Bar Service Office could no longer utilize you on a temporary part-time basis and you were terminated.

When asked about your availability to continuing working part-time during the week on specific days, you stated to Bar Service, and to Bonnie Henry, Staffing Manager, that you could not work on the days offered. After turning down the offers to work part-time on additional weekdays, Bill Aldom did submit a termination form for you stating a voluntarily quit due to another job as this was the reason given to Bill Aldom by you when you gave up your full-time position with us to pursue another full-time career opportunity. You were an at-will employee of Seven Springs Mountain Resort; Mr. Aldom's termination of your employment under these circumstances was appropriate.

We respect your personal decision to seek other employment on a full-time basis, and wish you the best with your new job and carrier. You were terminated, however, effective October 18, 2003, and therefore you must return your uniforms or pay for them.

- 1. The Township is the bordering Township to the applicant (Seven Springs) but will receive no funds, despite the use of Township resources, i.e. roads and water.
- 2. The Township has no police department and is concerned about the possible increased crime and law-enforcement issues.
- 3. The Township has not been consulted by either the applicant or any other government agency.
- 4. Middlecreek Township is a conservative Township and is a "dry" Township and the Supervisors are concerned about the social and moral issues created by the application.
- 5. The Township believes that it is in a unique situation in that Township resources will be used as a result of this application with no reimbursement, which is distinct from any other proposed application for license.
- 6. Apparently no provision has been made for any reimbursement to the Township for the use of the Township roads by potentially over-weight vehicles or by simply increased traffic, and no provision has been made for a decrease in the Township's water table, which is believed to be decreasing at an alarming rate.

- 7. The Township, therefore, essentially sees no revenue from the proposed application, so, therefore, there is no benefit to the Township, despite the use of the Township resources.
- 8. In any other application process familiar to the Supervisors of a similar nature, excess maintenance and/or bonding is required for the use of Township resources.

I am a 22 year-old black man and everyone else in this statement is white.

I was celebrating New Year's Eve Jan. 1, 2003 at Seven Springs Resort with a few friends. About 1:30 am we walked to the parking lot to catch a bus for the hotel. Someone told me a girl in the crowd had been hit and my friend Shawn Thompson (had gone to help her. I then went to find Shawn to make sure he was OK. I found him lying on the ground, unconscious. I began asking the people standing there who had done this when three men attacked me. During the fight one man was choking me. When I got away from him I was kneeling on the ground trying to catch my breath when a man hit me on my right jaw, fracturing it in four large pieces and many splinters. At that time I was knocked unconscious. A friend, Trace Vojtko (saw the man who hit me and said he had yelled racial slurs at me. While another friend, Jason Horner (was kneeling beside me holding my head and a CJ McClintok Security guard was standing at my feet, another man came running out of the crowd and kicked me in the chest also yelling racial slurs. The security guard did not attempt to protect me nor did he attempt to apprehend the man until Mr. Horner yelled at him to arrest the man. There were many security guards standing around that night and none of them were trying to stop the fighting, which my friends and I were involved. After I was taken to Somerset hospital and subsequently transferred to Conemaugh Hospital trauma center, as Somerset Hospital was not equipped to handle the severity of my injuries, Mr. Horner told a police Officer he wanted to file charges on my behalf. The Seven Springs police interviewed four or five men that my friends identified as the perpetrators and then let them go. There were no

I underwent surgery that afternoon and was released from the hospital Jan.

2. My family and I were waiting to hear from the Seven Springs Police

Department regarding the incident. When we had not been contacted my father
called Seven Springs police Chief Thomas on Jan. 3rd. Chief Thomas was not

there so my father told the officer he wanted to press charges against the men who attacked me. Chief Thomas called my father Sunday Jan. 5th and asked if we had photos. My father said yes but only after the surgery. My father at that time had told the chief of a non-partial witness (Sam Hallstrom,

) who had seen the whole incident and that he may want to interview him soon as he is in the military and would be leaving the country.

Jan. 10th - My father called Chief Thomas for an update on the investigation and he refused to give us any information.

Jan. 14th- Father called Police Department-Chief Thomas did not return call.

Jan. 15th- Father called Mr. Scott Bender, President of Seven Springs Inc. for information on the investigation. A police officer contacted us and said the Chief would return the call, as it was his investigation. Chief Thomas did not return the call.

Jan. 28th- Father and friend, Bob Huntley (former police chief of Johnstown) went to Seven Springs to meet with Chief Thomas and Somerset District

Attorney Jerry Spangler. My father was assuming Chief Thomas had information on my attackers and would be pressing charges. Instead, he accused me of starting the altercation (I have witnesses to the contrary) because that was the information he gathered from the men he detained New Years Eve. These were the same men my friends pointed out to be responsible for my injuries. DA Spangler wasn't interested in who started the fight he was only concerned with who assaulted me. My father produced the photos of my injuries including photos of my face immediately after surgery along with photos of the bruises on my head, chest, legs and arms. DA Spangler said the case was still open. My father suggested a media release since the police chief had what appeared to be only a hand full of written statements from a few witness the District Attorney said he thought that was a good idea but the next time my father asked Chief

Thomas about the media release he said Seven Springs wanted absolutely nothing to do with a media release. Chief Thomas also said that the security people were not cooperating with him and they fired one of them. In a later conversation with chief Thomas, he denied ever saying the security people were not co-operating. He also said that the security people do not get paid much and are basically useless in these kinds of things, they are more like bouncers. My father asked Chief Thomas if he had contacted Sam Hallstrom from IUP yet. Chief Thomas indicated he had not remembered Mr. Hallstrom was in the military. My parents located the phone number and contacted Mr. Hallstrom. He talked to my mother and told her what he had seen. My dad called Chief Thomas and gave him Mr. Hallstrom's phone number. A few days later when we went to Seven Springs to identify pictures my dad asked Chief Thomas if he had talked to Mr. Hallstrom. Chief Thomas replied "Yeah, he said he was drunk that night and also he had already left for the war". but I knew from my mother's conversation with Mr. Hallstrom that he was not leaving the country for another two weeks. He said he had been drinking that night, but he still remembered what the attacker looked like and what he was wearing. My dad knew from an earlier conversation with the chief that there was a couple from Florida involved because the chief had tried to blame me for punching the woman. Chief Thomas said he had talked to them and they were not coming back to press charges. Also, he said the male had a few lumps and my dad asked the chief where did they come from and he said probably your son. My dad said "then this is probably one of the perpetrators". My dad had also talked to a witness that said she was standing there when a guy punched his own girlfriend in the face. On the day we were looking at mug shots my dad asked if they had gotten the mug shot of the Florida man and the Chief flew off the handle and said my dad was testing his patience. Then he started yelling what's taking so long back there since my friend Trace was writing over his statement and looking at mug shots, the officer replied he is still writing. Then Chief Thomas called back and started complaining about the length of time Trace was taking. Chief Thomas has never called Jason Horner, my friend that was holding my head that night, to view mug shots or make a statement. As of this date March 18, 2003 no one has called or notified me of any arrests.



Re: Seven Springs Farm, Inc. (Docket #1365)

Gentlemen:

By way of introduction, I wish to inform you that I have been practicing law in Pennsylvania for 27 years and have had the privilege of representing Seven Springs Farm, Inc., for eight years, the last four of which as its designated corporate counsel. I have also been the solicitor for the County of Somerset for 19 years, the solicitor for the Rockwood Area School District (the school district in which Seven Springs Borough and the majority of the corporation's properties are located) for 27 years, as well as the solicitor for the Somerset Community Hospital for 27 years.

In these various roles, I have had the opportunity to recognize the unique phenomenon of the local government known as Seven Springs Borough and its interrelationship to the operations of Seven Springs Farm, Inc. It has come to my attention that there has been a request for an explanation as to the effect of the public official financial interest language as it pertains to former public officials that have been identified in the application. Some brief history, I believe, is important.

Seven Springs Borough has been incorporated since 1964. At the time it was incorporated, the municipality out of which it was formed, Middlecreek Township, Somerset County, was a "dry" municipality, i.e., did not permit the sale of alcoholic beverages. In order to obtain a license from the Pennsylvania Liquor Control Board, this entity was formed. The registered voters in Seven Springs Borough, the present number of which is 49, are either employees of the corporation, shareholders of the corporation or are related to employees or shareholders and are therefore ineligible to serve as public officials. All public officials, i.e., mayor, tax collector, borough council members, authority members, etc., are all non-paid volunteer positions.

When the legislature adopted the Pennsylvania Race Horse Development and Gaming Act, it recognized the uniqueness of the Seven Springs situation by including a provision identified as Section 1403 of Act 71 that treated this Borough, unlike other municipalities, as not receiving the host municipality two percent shared gaming revenues. In other words, Seven Springs Borough, being a host municipality for this resort application, would not be entitled to a two percent host municipality fee. The additional two percent would remain for the use of the Department of Community and Economic Development for grants to the County. As such, with the legislation precluding the Borough from receiving any gaming revenue, the public officials of Seven Springs Borough or its municipal authorities would have no input as to how gaming revenues would be spent.

In July, 2004 when the legislature adopted the Gaming Law, there were 16 of the 27 Seven Springs Borough public officials who were either employees of Seven Springs Farm, Inc., had a financial interest in the Resort or were related to employees or individuals with a financial interest thus making them ineligible under the current legislative language. These public officials would have had no way to know that on July 4th weekend, the legislature would act upon the House Bill, the Governor would sign the bill into law and that the law would become effective immediately thus barring these individuals from ever having the ability to hold an interest in a gaming license sometime in the future, notwithstanding that they were no longer public officials. No previous knowledge was provided to Seven Springs relative to a provision that would require the resignation of these individuals, especially with the inability to provide for qualified replacements. It would have been irresponsible for individuals to have resigned at that time without the added opportunity to have positions replaced with qualified electors because essentially, at the time there would not have been any eligible electors.

In November, 2004, the legislature further recognized the uniqueness of Seven Springs Borough by amending the Borough Code to provide that a borough with a population of less than 150 residents incorporated on or after January 1, 1964, may permit individuals that have not resided in the borough continuously for at least one year immediately before the election to be eligible to hold office. The previous provision of the Borough Code required that someone be a resident of the borough for at least one year before they are eligible to serve in any public official capacity. The import of this particular provision allows individuals to move into the Borough and be either appointed or elected to serve in a public official status without having to wait the one year for eligibility, thus providing some additional flexibility for expanding the pool of individuals available for the public official positions.

All public officials that have a financial interest in the Resort, or individuals employed by the Resort, have resigned prior to the filing of the application for this license. We have been informed that there is a presently-pending amendment to Senate Bill 862 which would amend the Gaming Law under Section 1305(A) by inserting at the end of subparagraph (A) the following:

Notwithstanding Section 1512, if at the time of the application, an applicant has terminated public office or employment as an executive-level public employee within the last calendar year, the applicant shall be eligible to apply for, be considered, approved, conditioned or denied a slot license under this section, but may not be issued a license until one year following the termination as a public official or executive-level employee.

I have further been informed that should the amendment fail to pass, which clearly would cure any issues that are referenced above, former public officials who are currently applicants would divest their interest in the license.

Because of the uniqueness of Seven Springs' situation, the former, volunteer public officials resigned prior to the application being filed, and, by the projected time of the application approvals, will have been former public officials for the year following termination and should not pose any additional concerns relative to the preclusion of licensure for former public officials. I believe the Gaming Control Board should recognize this unique situation understanding that according to their reported timetable of awarding the licenses by December 15, 2006, no former public official or executive-level employee will have had "public official status" for more than a year that would preclude licensure.


Biography


