- Excellent public transit access essential for a gaming and entertainment destination
- No other Applicant can match Riverwalk Casino's public transit access
 - Bus and Rail Stops within 2 blocks

- Subway, Streetcar or Trolley
- From Franklin Square to Spring Garden Station
- 2 stops within 2 blocks of Riverwalk Casino
- Connects with other major transit lines
- Water Taxi





- Restaurants strategically placed for patron enjoyment of Promenade and river views, with access from both the River and within the facility










- World-class casino space
 - 106,000 square feet to accommodate Phase One of 3,000 slots
 - 54,000 square feet expansion area to accommodate additional
 2,000 slots when approved
 - First-class finishings will be used throughout and the expansion space will not be noticeable to patrons
- Convenient access for main entrance
 - Valet/taxi/pedestrian arrivals
 - Self-park and bus arrivals from transportation center
 - Access via escalator to River Promenade

- Casino floor layout easily navigable by patrons
- Restaurants located riverside with glass walls and terrace dining
- Main casino floor area enlivened by central bar/lounge with entertainment
- 400 seat entertainment venue
- Retail shops conveniently located along major patron access route and fronting the building

TEMPORARY CASINO

- Riverwalk believes its energy and resources should be wholly focused on timely construction and opening of its permanent facility
- In the event the GCB determines inclusion of a temporary facility is significant, Riverwalk has secured a temporary site and will comply with all GCB requirements prior to constructing and operating, including appropriate traffic and local impact mitigation efforts

FINANCING

- \$94 million of <u>committed equity financing</u> and \$400 million of <u>committed bank financing</u>
- Equity sponsors collectively have over \$12 billion of assets under management
- \$500 million total funding exceeds estimated project cost, providing substantial cushion above and beyond imbedded construction contingency reserves and working capital
- \$50 million License Fee is secured
- Riverwalk Casino is in compliance with all financial fitness standards set forth in §441.5

WE ARE THE LOW RISK OPERATOR

- Capitalization allows for Riverwalk to:
 - Weather unforeseen increases in building materials and possible time delays due to labor shortages
 - Fund overtime and/or bonuses to accelerate construction
- Governance over construction funds and process along with significant experience will ensure Riverwalk Casino delivered on time and on budget
- Smaller site and focus on core amenities lessens risk of overspending and eventual bankruptcy
- Project-specific financing and management team to prioritize getting Philadelphia right

COMMITED TO BUILDING REVENUE IN PHILADELPHIA

- Riverwalk Casino does not have a sister property in a competing market. Its focus is to increase gaming revenue in the Commonwealth and Philadelphia
- A Bear Stearns Analyst report purports an operator may "develop customers and ship them to Atlantic City, where the gaming tax rates are lower."
- Applicants with casinos in neighboring & competing markets
 - Trump Entertainment & Pinnacle Atlantic City
 - Foxwoods Connecticut
- The Result: Riverwalk Casino is committed to increase gaming revenue in Philadelphia and thus taxes to the City and Commonwealth, unlike other Applicants

ADDITIONAL REVENUE FOR THE CITY

- Only Applicant to lease land from Government entity
- Penn's Landing Corporation Non-profit organization operating for the betterment of the City of Philadelphia
- <u>The Result:</u> Riverwalk Casino will provide over \$1.6 billion in additional revenue to the City and Commonwealth, unlike any other Applicants.

EMPLOYMENT

- The Operating Group is union friendly
 - 7 years experience with UNITE HERE, who will represent some of Riverwalk Casino's employees
 - During Bay Harbour's ownership of Barneys retail chain,
 twice renewed the union contract smoothly and
 successfully for each side
 - Following the negative effects of 9/11, Mr. Teitelbaum and other board members eliminated board fees and withheld management bonuses to prevent job losses
 - The Aladdin was one of 3 non-union properties on Las
 Vegas Strip and upon acquisition the Operating Group
 signed a 3-year collective bargaining agreement

EMPLOYMENT

- Riverwalk is in discussions with local universities and other educational institutions to promote the training and hiring of local Philadelphians
- Entered into an agreement with UNITE HERE, IUOE and IBT
 - Riverwalk Casino supports union labor
 - The operating group maintains strong relationships with UNITE HERE and other union labor groups in its other operations
- Patrons recognize and appreciate happy, well-trained employees and may frequent more often as a result.
- The Result: Riverwalk Casino is dedicated to employing and training happy workers to increase revenue to the City and Commonwealth

SUPPORT FOR LOCAL BUSINESSES

Beyond local ownership, Riverwalk has sought Philadelphian vendors with excellent credentials

- Other community involvement
 - Local consultants
 - Local restaurants and entrepreneurs
- The Result: By working with vendors in Philadelphia and Pennsylvania, The Commonwealth will receive more tax revenue and other economic benefits.

BENEFIT TO LOCAL HOTELS

- Riverwalk Casino specifically chose not to include a hotel connected to the casino facility
- Riverwalk Casino will benefit existing hotels by boosting their occupancy, rather than increasing the City's room supply like all other Applicants
- Adding to the room supply could cause downward pressure on room revenue throughout the City
- The 54% tax rate does not allow casinos to comp players like in other lower-gaming-tax markets
- The Result: Riverwalk Casino will enhance tourism by working with hoteliers and the Greater Philadelphia Hotel Association. Riverwalk Casino will improve the City's occupancy and room rates

OPTIMAL SIZE

- We wish to make clear—our site could contain a hotel by building upward
- We contend Philadelphia hotels have excess capacity, evidenced by the 73.1% occupancy rate
- We will work with local hotels, not be in competition with them
- The Riverwalk Casino group considered other sites, including those of some Applicants, but turned others down because smaller sites maximize access to roads and public transportation
- Larger sites with more amenities cause more traffic and detract business from existing businesses

ECONOMIC IMPACT

- The Input-Output/Social Accounting Matrix Model was used to determine Riverwalk Casino's economic impact
- Used to depict how the total output of each industry in an economy depends on inter-industry demands and final demands
- This concept, conceived in the 18th century and developed in the 1930s resulted in a 1973 Nobel Prize in Economics

DURING CONSTRUCTION

- Direct Investment: \$500 million
- Over \$320 million impact on Total Output
- Over \$110 million impact on wages
 - Over \$75 million direct impact on wages
- Over 2,600 newly created jobs
 - Over 1,700 jobs in construction sector
- Over \$24 million impact on overall tax revenue

DURING OPERATION

- Over \$330 million impact on Total Output
 - Over \$260 million direct impact
- Over \$70 million impact on wages
 - Over \$45M direct impact
- Over 2,900 newly created jobs
 - Over 2,200 direct impact
- Over \$180 million impact in gaming taxes in first year
- Additionally, over \$23 million impact in total other taxes

LOCAL SERVICES

- Local Police
 - Increase in police staffing
 - A new police station is not necessary
 - Estimated cost of \$1.1 million to \$2.3 million per year
- Local Fire Department
 - Less impact than Police since the casino may not lead to increased residency in the area
 - Estimated cost of \$0.2 \$0.5 million per year



Impact from Future Operations

- Delaware Ave & Spring Garden require capacity improvement mitigations to improve Level of Service
- Minor impacts at all other study area intersections
- Develop time of day, day of week signal timing plans for all study area intersections
- Roadway improvements to increase capacity at Delaware Avenue and Spring Garden Street
- New traffic signal at garage access





TRANSPORTATION COORDINATOR

- Upon award of a gaming license, Riverwalk Casino will hire a Transportation Coordinator ("TC")
- Initially, TC will oversee preparation of a site-specific
 Transportation Management Plan
- Ultimately, TC will be responsible for planning, implementation and evaluation of all traffic management strategies to efficiently and effectively achieve established objectives

TRANSPORTATION COORDINATOR

- Transportation Coordinator responsibilities include:
 - Develop a site-specific plan, including for special events
 - Manage traffic operations both internally and externally
 - Coordinate data collection, evaluate conditions and implement strategies as part of the TMP
 - Evaluate employee and patron behavior, establish goals and objectives to reduce traffic congestion and define overall measures of effectiveness
 - Monitor transportation modes, travel characteristics and measures of effectiveness of the implemented strategies
 - Work closely with PennDOT, City Streets Dept., Penn's Landing Corp. and other involved agencies along the Delaware River waterfront
