Wagering Restrictions Notice

The list of individuals who are prohibited from wagering in accordance with Pennsylvania Gaming Control Board regulations is detailed below by entity and license type. Individuals with questions about these restrictions should call 877-500-PGCB(7422). This list is a guide for restrictions as regulated by our agency, employees should confirm their employer's compliance officer to determine if there are wagering restrictions imposed by the employer.

Principal or Key License, Gaming Permit and Non- Gaming Registration (Temporary or Permanent)	Any individual who is issued a principal or key license, gaming permit or non-gaming registration and who is employed by or associated with a casino is prohibited from wagering at the casino in which the individual is employed or associated. Additionally, any individual who is issued a principal or key license, gaming permit or non-gaming registration must wait 30 days from the last date of employment before wagering at the casino where the individual was employed.

Interactive Gaming Wagering Restrictions

Casino Employees

Principal or Key License, Gaming Permit and Non- Gaming Registration (Temporary or Permanent) §808.1(g)(1)	An individual whose job duties include interactive gaming and who holds a license, permit or registration and is currently employed by or is a principal of an interactive certificate holder may not place wagers on web sites offered by or associated with the interactive certificate holder. The licensed, permitted or registered individual shall wait at least 30 days following the date that the individual is no longer employed in a position that includes interactive gaming job duties before the individual may wager on web sites offered by or associated with the interactive certificate holder.
	Any employee of a brick and mortar casino who is not required to obtain a license, permit or registration as a condition of employment is prohibited from wagering at the brick and mortar casino in which the employee is employed.

VGT Terminal Operator, Manufacturer & Supplier Employees

Horse Race Wagering Restrictions

All Employees

The PGCB does not restrict wagering on horse races in Pennsylvania. The employee should confer with their employer and the Horse Racing Commission to determine if there are wagering restrictions imposed by the employer and/or Horse Racing Commission.
