PGCB MOTION NO. 2005-35 REG – Adoption of the Responses to the Public Comment for Category 2, 3, and BIE Regulations

Resolved, the Board hereby adopts the responses to the Public Comment for Category 2, 3, and BIE Regulations.

PGCB RESOLUTION NO. 2005-5 REG – Adoption of the Draft Regulations as Temporary Regulations for Category 2, 3 and Bureau of Investigation and Enforcement

Motion Made: Board Member Colins Seconded: Board Member Marshall

Whereas On July 5, 2004, the Pennsylvania General Assembly enacted the

Pennsylvania Race Horse Development and Gaming Act, establishing the Pennsylvania Gaming Control Board as the primary regulatory agency charged with the responsibility of implementing and overseeing slot

machine gaming in the Commonwealth; and

Whereas The Act authorizes the Board to adopt "temporary" regulations in order to

facilitate the prompt implementation of the Act during the two years

following the Act's effective date; and

Whereas The Board has developed draft temporary regulations governing the duties

and powers of the Bureau of Investigations and Enforcement, general licensing requirements for the slot machine licensees and licensing requirements for Category 2 and Category 3 slot machine licenses; and

Whereas The public has had an opportunity to comment on the draft temporary

regulations, and the Board has incorporated appropriate public comments

into the regulations; and

Whereas The Board's final temporary regulations are designated as Title 58 Recreation, Part VII Gaming Control Board:

• Subpart A., General Provisions, specifically Chapter 405, Bureau of Investigations and Enforcement

• Subpart C., Slot Machine Licensing, Chapter 441 Slot Machine Licenses, specifically section 441.13, Notification of anticipated or actual changes in key employee qualifiers or key employees and section 441.14, Notification of new financial sources; and Chapter 443 Categories of Licensure, specifically sections 443.4, Category 2 slot machine license and 443.5, Category 3 slot machine license

Whereas The Board reserves the right to amend the temporary regulations as it deems necessary in accordance with the purpose of the Act and in order to

further the intent of the Act; be it

RESOLVED That the Board adopts the draft regulations as its temporary regulations for

the general duties and powers of the Bureau of Investigations and Enforcement, general licensing requirements for the slot machine licensees and licensing requirements for Category 2 and Category 3 slot

machine licensees.

PGCB MOTION NO. 2005-36 REG – Posting of the Draft Temporary Regulations pertaining to Slot Machine Movement and Ownership for Public Comment

Resolved, the Board hereby approves the posting of the draft temporary regulations pertaining to Slot Machine Movement and Ownership through the publication of the regulations in the Pennsylvania Bulletin and through the Board's website. The Board hereby designates a public comment period of 30 days beginning September 28, 2005 and ending on October 28, 2005.
