# PGCB RESOLUTION NO. 2006-5 REG – Adoption of the Temporary Regulations for Intervention

Whereas On July 5, 2004, the Pennsylvania General Assembly enacted the

Pennsylvania Racehorse Development and Gaming Act, establishing the Pennsylvania Gaming Control Board as the primary regulatory agency charged with the responsibility of implementing and overseeing slot

machine gaming in the Commonwealth; and

Whereas The Act authorizes the Board to adopt "temporary" regulations in order to

facilitate the prompt implementation of the Act during the two years

following the Act's effective date; and

Whereas The Board has developed draft temporary regulations governing the

Intervention process; and

Whereas The public has had an opportunity to comment on the draft temporary

regulations; and

Whereas The Board's final temporary regulations are designated as Title 58,

Recreation, Part 7, Gaming Control Board, Subpart H, Practice and Procedure, Chapter 493, pleadings, specifically, Section 493.13; and

Whereas The Board reserves the right to amend the temporary regulations as it

deems necessary and in accordance with the purpose of the Act and in

order to further the intent of the Act; be it

RESOLVED That the Board adopts the draft regulations as its temporary regulations for

the Intervention process.
