A quorum of the Board being present Commissioner Colins, presiding over the meeting in Chairman Decker's absence, called the meeting to order.

Commissioner Colins announced that the Board held executive sessions on June 15 and prior to the meeting to discuss personnel matters. No business was conducted at these sessions. Commissioner Colins announced the June 29th deadline to apply for the Category 3 licenses and Local Law Enforcement Grant.

Commissioner Colins also announced that the Board received a petition from Greenwood Gaming and Entertainment which requests an extension to provide a licensed facility expansion
