A quorum of the Board being present, Chairman Fajt called the meeting to order.

ANNOUNCEMENTS

Chairman Fajt announced that the Board held an Executive session on August 27, 2009 to discuss personnel issues, to conduct quasi-judicial deliberations relating to matters pending before the Board and to consult with counsel regarding privileged and confidential agency business.

MINUTES AND TRANSCRIPTS

On a motion by Board Member Sojka, seconded by Board Member Rivers, the minutes and transcripts of the June 17 and July 15, 2009 meetings were unanimously approved.

EXECUTIVE DIRECTOR'S REPORT

Mr. Kevin O'Toole, Executive Director, provided an update on the Rivers Casino. He stated that the Rivers has invested more than \$780 million into the facility which includes a 123,000 square-foot gaming floor with 3,000 slot machines, four restaurants, multiple lounges, a 1,000 seat amphitheatre and a parking garage. Most importantly, this facility is providing over 1,000 living wage jobs. The opening is the culmination of many weeks of hard work by our staff, State Police, Department of Revenue, and the staff from the Rivers working closely together to insure that the new facility was prepared for the public. Mr. O'Toole thanked Commissioners McCabe and Rivers for their oversight of the test sessions; to the dedicated opening team, which included members from gaming operations, the gaming lab, casino compliance representatives, licensing analysts, information technology staff and legal counsel. He also commended the many long hours of investigation by BIE staff and the Office of Enforcement Counsel in the lead-up to the opening. Mr. O'Toole then updated the Board on the July revenue figures indicating that those revenues have climbed month over month. Overall, an 18 percent increase in gross terminal revenue over July of last year - a figure that includes revenue from the Sands Casino in Bethlehem. Mr. O'Toole stated that beyond our state boundaries, Pennsylvania, in just less than three years, has established itself as an important east coast slots gaming destination. Only New Jersey, with its 11 casinos, outpaced Pennsylvania in total revenue with \$266 million in gross terminal revenue compared to \$207 million in gross terminal revenue in Pennsylvania for July at our 9 casinos according to the "East Coast Slots Report". Mr. O'Toole emphasized the importance to note that due to our tax structure, -- 55% compared to 9% -- far more revenue is being returned to Pennsylvanians to pay for property tax relief, economic development and other important programs. Putting the tax revenue in perspective, during July, Pennsylvania casino slot play produced \$98 million in taxes equating to just over \$3 million per day.
