#### **OATH OF OFFICE**

### MINUTES AND TRANSCRIPTS

On a motion by Board Member Angeli, the minutes and transcript of the October 21, 2009 were approved 6-1. Board Member Kenneth Trujillo abstained.

#### **EXECUTIVE DIRECTOR'S REPORT**

Kevin O'Toole, Executive Director, reported on the revenue figures for the month of November 2009. He stated that nine operating casinos generated gross terminal revenue of \$166 million dollars during November. This revenue generated over \$91 million dollars in tax receipts for the Commonwealth of Pennsylvania. Mr. O'Toole stated that it was encouraging to see the market for casino entertainment continuing to grow in Pennsylvania.

He also reported that Mary Colins, our former Chair of the Pennsylvania Gaming Control Board, received a "Special Recognition Award" from the Council on Compulsive Gambling of Pennsylvania. Mary, he said, was instrumental, along with Commissioners Coy and McCabe, in establishing very comprehensive responsible gambling regulations. In closing, he stated that the Office of Compulsive and Problem Gambling does an outstanding job in monitoring the casino's efforts to insure a strong commitment to responsible gambling programs and initiatives. Mr. O'Toole recognized Nan Horner, Liz Lanza, Elizabeth Burch and Daria Manning for their dedicated work on Compulsive and Problem Gambling.

has general and sole regulatory authority over the conduct of gaming and related

WHEREAS Under 58 Pa.Code §467a.2(b), a Category 2 slot machine licensee may not commence

slot operations until a slot machine licensee successfully demonstrates to the Board that no less than nine criteria are met including, but not limited to, confirmation that the slot machines and associated equipment are properly operating; that adequate surveillance and security measures are in place; that the slot machine licensee's employees are all properly licensed, permitted or registered by the Board, as well as, properly trained; that all conditions of licensure have been met; and that the slot machine licensee has

successfully completed a test period; and

WHEREAS The Board has, in the past, delegated authority upon certain members of the Board,

acting collectively, to review whether all pre-opening criteria have been met and to grant authorizations on behalf of the full Board when the required criteria have been

met; and

WHEREAS The Board believes it is once again in the Board's best interest to delegate such

authority to certain members of the Board

RESOLVED That Board members Raymond Angeli, James Ginty and Kenneth Trujillo are delegated authority to determine whether Greenwood Gaming and Entertainment, Inc., d/b/a Philadelphia Park Casino and Racetrack has demonstrated that all pre-opening criteria have been met and to authorize commencement of slot operations for the Parx Casino. The Board members delegated this authority shall also have the authority to approve minor modifications of any gaming floor plan previously approved by the full Board between the date of such Board approval and the commencement of slot operations.
