## **EXECUTIVE DIRECTOR'S REPORT**

Kevin O'Toole, Executive Director, reported that Governor Rendell signed Senate Bill 711 yesterday authorizing the legalization of table games at Pennsylvania's casino facilities. He stated that this bill represents the culmination of a significant effort to expand legalized gambling from slot machine-only facilities to full service casinos providing a wide array of casino-related services. He reported that the law promises great expansion of economic and employment opportunities for casinos and Pennsylvania citizens alike. He also commented that it also requires extraordinary dedication and commitment of Board staff to see that the mandates of the new law are fulfilled.

Mr. O'Toole further updated the Board on what staff has been able to do, and what, as an agency we still need to do to implement and effectively regulate table games. Mr. O'Toole commented that there is a lot of work ahead.
