EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole, Executive Director, reported that as part of the Board's initiative to insure the proper regulatory oversight of table games operations, he instructed the Bureau of Financial Management and Administration to prepare an RFP for the purpose of soliciting an expert to perform educational and training seminars in the area of table games security and protection. The successful bidder will provide training to all Board staff with responsibilities to oversee the integrity of table game play, and in particular the Board's on-site Casino Compliance Representatives. Mr. O'Toole stated that it is expected that all attendees of these training sessions will gain a fundamental understanding of table games sufficient to recognize basic red flags and other suspicious activity that would cause that employee to further investigate an incident, event or person.
