Meeting of the Board May 13, 2010 Minutes

A meeting of the Pennsylvania Gaming Control Board was held on May 13, 2010 at the North Office Building, Hearing Room 1, Harrisburg, PA. The meeting began at approximately10:00 a.m.

A quorum of the Board being present, Chairman Fajt called the meeting to order.

ANNOUNCEMENTS

Chairman Fajt announced that the Board held an Executive session on May 12th and just prior to the public meeting on April 29th in accordance with the Sunshine Act. The purpose of the executive session held on April 28th was to discuss personnel matters, pending litigation, and to conduct quasi-judicial deliberations relating to matters pending before the Board. He stated that the executive session held on May 13th, following the public hearings, were to conduct quasi-judicial deliberations relative to those hearings.

MINUTES AND TRANSCRIPTS

On a motion by Board Member Angeli, seconded by Board Member Coy, the minutes and transcripts of the March 23 and April 7, 2010 meetings were approved.

EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole, Executive Director reported that the gross terminal revenue was 29.6 percent higher in April 2010 compared to the previous year. As you know, there were 9 casinos this April compared to 7 last year. He commented that the revenue figure for April 2010, over \$107 million dollars in that month alone was added to the funds primarily earmarked for property tax relief.

Mr. O'Toole stated that table games implementation continues to move forward steadily and surely. To date, the Bureau of Licensing has received approximately 1,500 applications for table game related positions and he expects that figure to rise significantly in the next 2 to 3 weeks. We are also encouraged by the fact that there are 6 table game manufacturers approved and 1 additional before the board today. Mr. O'Toole stated that educational training will commence next week for our employees to learn fundamental principles of table game operations and table game protection. In closing, he advised the Board that the instructor for those sessions will be Mr. George Joseph, a nationally recognized expert in table games protection who has conducted educational training for casino regulatory agents in many jurisdictions throughout the United States.
