## Meeting of the Board June 10, 2010 Minutes

A meeting of the Pennsylvania Gaming Control Board was held on June 10, 2010 at the North Office Building, Hearing Room 1, Harrisburg, PA. The meeting began at approximately10:00 a.m.

Chairman Fajt announced that the Board held an Executive session on June 9<sup>th</sup> in accordance with the Sunshine Act. The purpose of the executive session was to discuss personnel matters, pending litigation, and to conduct quasi-judicial deliberations relating to matters pending before the Board.

Chairman Fajt announced the resignation of Deputy Executive Director, Frank Donaghue. Chairman Fajt presented Mr. Donaghue with a Resolution outlining his excellent service to the Pennsylvania Gaming Control Board.

## PGCB RESOLUTION 2010-2-EXE – FRANK DONAGHUE Adopted June 10, 2010

WHEREAS, On March 1, 2006, Frank Donaghue was hired by the Pennsylvania Gaming Control Board as the agency's first Chief Counsel; and

WHEREAS, Frank Donaghue was tasked with assembling the Office of Chief Counsel with highly skilled and competent attorneys and staff to oversee the drafting and development of Board regulations and policies, administrative matters, hearing and licensing processes as well as the defense of Board decisions from appeal, all in an effort to create a new agency and implement the new gaming industry in Pennsylvania; and

WHEREAS, Frank Donaghue also served as the Acting Executive Director during an important transition period for the Board and assumed additional duties as necessary to assure the success of the Pennsylvania Gaming Control Board; and

WHEREAS, Frank Donaghue has worked steadfastly toward the creation of a fully functioning agency, the proper implementation of gaming and the enhancement of the Board's operations and regulation of the gaming industry; and

WHEREAS, the development of the Pennsylvania Gaming Control Board during Frank Donaghue's tenure as Chief Counsel and Acting Executive Director is a matter of which the full Board is both proud and appreciative; be it

RESOLVED that the Pennsylvania Gaming Control Board proudly recognizes Frank Donaghue for his exemplary record of leadership and congratulates Frank on his service to the Pennsylvania Gaming Control Board and wishes him the very best in all his future endeavors.

## **EXECUTIVE DIRECTORS REPORT**

Kevin O'Toole, Executive Director announced the release of a Table Games Schedule for testing and implementation that will result in the first public availability of table game gambling in Commonwealth slots casinos as early as July 8<sup>th</sup>.

He presented the schedule and by letter to each casino that holds an approved table games certificate. He said the schedule includes an eight-hour test period of live betting at each casino to permit Board personnel to determine if the casino is prepared in all aspects to open its table game operation. If approval is given after the test period, Mr. O'Toole says casinos can go live with table games two days later after allowing for one "down day" to evaluate the test including meetings of PGCB and casino personnel to discuss the results of the test period.
