A quorum of the Board being present, Chairman Ryan called the meeting to order.

ANNOUNCEMENTS

Chairman Ryan reported that the Board held an Executive Session on April 10th for the purpose of discussing personnel matters, pending litigation and to conduct quasi-judicial deliberations relating to matters being considered by the Board on April 11th. A second Executive Session was held on April 11th following the public hearings.

MINUTES/TRANSCRIPT

On a motion by Commissioner Fajt, seconded by Commissioner Ginty, the minutes and transcript of the February 29, 2012 meeting were approved.

EXECUTIVE DIRECTOR'S REPORT

Kevin O'Toole reported on the opening of the first Category 3 casino in Pennsylvania that occurred on March 31, 2012 when Valley Forge Casino Resort opened following two 6-hour test periods. He stated that the opening team, led by Jeanne Ort-Motto, Jerry Stoll, Michael Cruz and John Sentell, worked diligently in the final weeks before the opening to assist the Valley Forge management team. The opening team assistance was to ensure that all aspects of the casino facility and the casino workforce met the regulatory requirements to open to the public.

Mr. O'Toole further stated that the Bureau of Investigations and Enforcement and the Bureau of Licensing also deserve much credit for their efforts in getting over 900 employees properly credentialed to work at Valley Forge Casino. He further commented that the test periods proved to be important as all casino-related computer systems were tested, employee training was evaluated and table game dealers were closely observed.

In closing he offered his thanks to Chairman Ryan, Commissioner Fajt and Commissioner Ginty for participating in the Valley Forge opening as the delegated members of the Board who reviewed the results of the test periods and gave final approval to Valley Forge to begin operations.
