Resolved, the Board hereby approved Consent Agreement between the Office of Enforcement Counsel and Greenwood Gaming & Entertainment, Inc. Greenwood Gaming shall pay a civil penalty in the amount of ten thousand dollars (\$10,000) for failing to abide by the terms of its signed Statement of Conditions and failure to comply with its approved Compulsive and Problem Gambling Plan by allowing an intoxicated patron to continue to gamble after the patron's intoxication was apparent. In addition, Greenwood Gaming shall pay an additional twenty-five hundred (\$2,500) for costs incurred by the Office of Enforcement Counsel, Bureau of Investigations and other related staff in connection with this matter. Both fines are to be paid within five business days from the date of the Board's Order.

IGT shall pay a civil penalty in the amount of five thousand (\$5,000) and an additional two thousand five hundred dollars (\$2,500) for the costs incurred by the Office of Enforcement Counsel, Bureau of Investigations and other related staff in connection with this matter. The fines are due ten days from the date of the Board's Order.

In addition, DEQ Systems shall pay two thousand five hundred dollars (\$2,500) for the costs incurred by the Office of Enforcement Counsel, Bureau of Investigations and other related staff in connection with this matter. The fines are due within five business days of the Board's Order.
