

Hollywood's Superstar Team

- 1044 employees pre-tables in 2010 → 1236 employees today
- Approximately 344 in-house promotions since opening in 2008
- Total salaries and wages paid since opening: \$126.3M (through 2012)
 - 84% of team members are hourly with an average hourly rate of \$15.77 (including tips)
 - 16% of team members are salaried with an average annual salary of \$59,895
- Second-highest employee engagement scores in all of the Penn National portfolio of properties



Hollywood's Superstar Team

- Total employee benefits paid since opening: \$26.1M (through 2012)
 - Medical/Dental premiums
 - 401(k) contributions (with 50% company match up to 6%)
 - Tuition reimbursement (over \$50,000 paid out since 2011)
 - Disability and life insurance
 - Employee wellness activities (gym memberships, Weight Watchers competitions, softball and basketball tournaments)
 - Employee help-line



A Diverse Cast of Team Members

- 45.1% of team members are female
 - 35.3% of Executives/Managers/Professionals are female

 - 15.4% of Executives/Managers/Professionals are minorities
- 98.7% of team members are Pennsylvania residents

A Culture of Responsible Gaming

 At Hollywood Casino, Responsible Gaming permeates every aspect of our culture.





"We Care" that you enjoy yourself, but never wager more than you can afford to lose.

"We Care" about your children and make every effort to ensure that no one under 21 is on the casino floor, wagering in the casino or consuming alcohol. No one under age 18 is allowed to wager on horseracing.

"**We Care**" about responsible gaming and are proud of the fact that we make it part of the Hollywood Casino culture.

Responsible Gaming Training

- Every HCPN employee completes Responsible Gaming training as part of their initial orientation
 - Training program designed in consultation with the PGCB Office of Problem and Compulsive Gaming and the Council on Compulsive Gambling of Pennsylvania
- Gaming and Security employees complete more extensive orientation training for Responsible Gaming
- All HCPN employees complete annual Responsible Gaming refresher training



Property Self-Exclusion List

- HCPN maintains a Property Self-Exclusion
 List to supplement the PGCB statewide Self-Exclusion program.
 - HCPN always promotes the PGCB list first
 - If a guest opts not to participate in the statewide list, HCPN then offers the alternative to selfexclude from our facility
 - Approximately 400 property self-excluded guests on the HCPN list




Responsible Gaming Education Week

- Each year, HCPN competes with other Penn National properties during Responsible Gaming Education Week to create a program that promotes responsible gaming to team members, guests, the media, and the public at large.
- HCPN's programs have included:
 - Responsible Gaming Celebrity Charity Poker Tournament
 - Responsible Gaming Fireworks Night at Harrisburg Senators
 - Responsible Gaming "Tagline" competition on Facebook
 - Creation of a Responsible Gaming "Theme Song"
 - Multiple Public Service Announcements broadcast on local television and radio stations
 - Employee contests and competitions

Preventing Underage Gaming

- HCPN is committed to the prevention of underage gaming at our casino.
- In 2012, HCPN carded over 300,000 individuals appearing to be 30 years or younger attempting to enter the casino.
 - Turned away over 3,100 underage or potentially underage individuals (over 8 per day)

Preventing Underage Gaming

Safeguards include:

- Signage and "STOP!" signs at every entrance, clearly stating that guests must be 21 years old to access the casino floor
- ID requested from any individual appearing to be 30 years or younger
- Every entrance is equipped with electronic ID scanners, which can verify a guest's age and whether the identification provided is valid

- Colored wristbands are provided to guests who have been carded and verified
- Security doubled at entrances during peak periods
- Billboards rotated through our market that advertise that guests must be 21 years or older to visit the casino



Preventing Underage Gaming

<u>100 days – 100 dollars</u>

- Every time Security goes 100
 consecutive days without allowing an
 underage individual onto the gaming
 floor, all eligible Security officers
 receive a \$100 cash bonus
- To date, we have paid out 3 times, totaling approximately \$30,000 in bonuses
- Widely popular with Security staff as the 100 days draws closer, the entire team is encouraging each other to reach the goal

<u>Finders – Keepers</u>

- If an underage individual is turned away from an entrance, the officer communicates the turn-away to all other officers and posts
- If another officer later turns away the same guest again trying to enter, both the initial and final officer are awarded a \$25 Hollywood Casino gift card
- Again, very popular with Security staff, as it encourages detailed communications regarding repeat underage attempts



Industry Leader in Regulatory Compliance

- Onsite Compliance Manager to assist in all regulatory matters
- Comprehensive system of Internal Controls safeguards all assets and revenues, and ensures proper segregation of duties
- Positive working relationship with PGCB offices and onsite regulatory staff
- Consistent history of self-reporting all discovered regulatory violations



Reinvestment Projects

- \$4M annual slot replacement/refurbishment budget
- \$250k remodeling of our High-Limit Blackjack pit (2013)
- \$1.2M carpet replacement across the entire gaming floor (2013)
