- 6 MS. HENSEL: At this point in time, based on
- 7 the materials and information in the application and
- 8 cooperation received by the applicant, the Bureau of
- 9 Licensing is not aware of any issues that would preclude
- 10 licensure of Hamlet Holdings, LLC.
- 11 MR. PITRE: The Bureau of Investigation and
- 12 Enforcement has completed its background investigation
- of Hamlet Holdings, LLC.
- 14 As a result of the investigation, the Bureau
- 15 has not identified any suitability issue, which would
- 16 preclude the approval of the transaction relating to the
- 17 acquisition or the change of ownership or control in
- 18 this matter. The Office of Enforcement Counsel also
- 19 affirms that.
- 20 CHAIRMAN DIGIACOMO COLINS: Okay. Good. Thank
- 21 you very much. That will close the record on that
- 22 matter.
