Dear Ms. Drayton-Brown:

Please accept this letter in lieu of more formal amendment to the petition of Chester Downs and Marina, LLC d/b/a Harrah's Chester Casino & Racetrack's ("Harrah's Chester") for approval of authorization and issuance of a Table Games Operation Certificate (the "Petition") filed with you on March 3, 2010.

Harrah's Chester seeks to modify certain of the numbers and types of table games for which it seeks approval. Enclosed for your consideration is Amended Appendix 3 which incorporates the following changes to Harrah's Chester's proposed table games array:

- (1) Pai Gow Tiles table is reduced from one (1) to zero (0), and
- (2) Blackjack tables is increased from forty nine (49) to fifty one (51), which includes six (6) High Limit Blackjack tables and one (1) ADA Blackjack table.

You will note that the total number of table games as described in the Petition remains the same.




