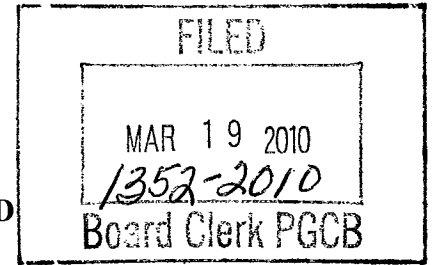

**FIRST SUPPLEMENT TO THE PETITION OF PRESQUE ISLE DOWNS, INC.
FOR APPROVAL OF AUTHORIZATION TO CONDUCT TABLE GAMES AND
ISSUANCE OF A TABLE GAMES OPERATION CERTIFICATE**

Presque Isle Downs, Inc. d/b/a Presque Isle Downs ("PIDI") submits this FIRST SUPPLEMENT to its initial Petition For Table Games Authorization submitted pursuant to Section 1312A of the Pennsylvania Race Horse Development and Gaming Act as amended by Act No. 1 of 2010, ("Gaming Act"), 4 Pa. C.S. § 1312A, requesting this Honorable Board grant this petition ("Petition") and issue a table games certificate for its licensed facility in Summit Township, Pennsylvania. PIDI is suitable and meets all of the statutory requirements for a table games operation Certificate; therefore, it is respectfully requested the Certificate be issued by the Board. In support of this First Supplement, PIDI avers,


1. On March 2, 2010 PIDI filed its Petition for Approval of Authorization to Conduct Table Games and Issuance of a Table Games Operation Certificate ("Table Games Petition") with the Pennsylvania Gaming Control Board.
2. Simultaneous with the filing of its Table Games Petition, PIDI filed a Motion to maintain the Confidentiality of specific sections of Petition and required appendices attached thereto; said Motion is incorporated herein by reference.

3. On March 5, 2010 PIDI was notified that it was required to supplement its Table Games Petition. See Exhibit "1".
4. Each of the items noted in Exhibit 1 have been addressed and are attached hereto and labeled Appendix S1-4, S1-6, S1-8 and S1-11.
5. PIDI hereby incorporates by reference the Motion for Confidentiality filed on its behalf on March 2, 2010, and renews its request for Confidential Treatment of S1-6 and S1-8.

WHEREFORE, Presque Isle Downs, Inc. ("PIDI"), having cured the deficiencies noted in Exhibit "1", is hereby requesting that its Petition for Table Games be deemed Complete, and that this Honorable Board grant PIDI's Petition for Table Games and issue it a table games operation certificate.



Nick –

Please provide the following information to supplement the table game petition:

1. Appendix 4: Please specify the number of part time and full time employee positions that will be created. The petition mentioned 500 employees. How many of these positions will be full time vs part time.
2. Appendix 6: Provide a commitment letter. The letter must specify that Presque Isle's parent company has committed funds to the Presque Isle project. The executed commitment letter must be from the CEO or CFO who has the authority to legally bind the slot machine licensee, which indicates that the entity has the committed funds.
3. Appendix 8: Provide an overall budget for 2010 and the revenue projections from the table game operations if approved.
4. Appendix 11: Please provide a signed waiver of rights from Lynda Jacobs, Thomas Trygar, and the 6 minor children, we will need signature from the representative who is authorized to sign on the minor's behalf. We need a signature for each minor child.


