# RIVERS CASINO DEALER TRAINING CURRICULUM

#### **OVERVIEW**

The goal of the Rivers Casino table games training school is to teach prospective applicants and / or existing employees how to proficiently deal all table games offered by the Rivers Casino in a friendly and professional manner. Students will learn the policies and procedures, approved internal controls, and game protection techniques for respective table games. Instructors will be chosen based on their prior table games experience which includes training and game protection experience. Students will be required to pass written tests and dealing auditions in order to be certified to deal and/or supervise any game offered by the Rivers Casino.

All training will take place at the Rivers Casino.

#### **COURSE LENGTH**

**Introduction to Table Games** 6 hours

Blackjack: 6 weeks (120 hours)
Craps: 8 weeks (160 hours)
Roulette: 4 weeks (80 hours)
